PROMOTION OF RELIGIOUS AND CULTURAL TOURISM IN BAREILLY

†931. SHRI CHHATRAPAL SINGH GANGWAR:

Will the Minister of TOURISM be pleased to state:

- (a) the steps taken by the Government to promote religious and cultural tourism in Bareilly; and
- (b) the details of new schemes by the Government to connect Bareilly to new tourist places nearby Nainital?

ANSWER

THE MINISTER OF TOURISM (SHRI GAJENDRA SINGH SHEKHAWAT)

(a): The development and promotion of tourism destinations and products are primarily undertaken by the concerned State Government (SG)/Union Territory Administration (UT). However, the Ministry of Tourism as a part of its ongoing endeavour promotes various tourism destination and product of the country including religious and cultural tourism in Bareilly through promotional activities, events, website, social media promotions etc.

The Ministry of Tourism through its central sector schemes of 'Swadesh Darshan (SD)', 'Pilgrimage Rejuvenation and Spiritual, Heritage Augmentation Drive (PRASHAD)' and 'Assistance to Central Agencies for Tourism Infrastructure Development' complements the efforts of tourism infrastructure development in the country by extending financial assistance to the State Governments/UT Administrations. This process is undertaken in consultation with state Governments/UT Administrations. No project has been sanctioned in Bareilly under the above mentioned schemes of the Ministry of Tourism. However, Ministry of Tourism has sanctioned various projects in Uttar Pradesh, details of which are in given in the annexure.

(b): The Ministry of Tourism has not formulated any new scheme specifically to connect Bareilly with nearby tourist destination in Nainital. Proposals are received from State Governments/UT Administrations from time to time for seeking financial assistance under the various schemes of the Ministry of Tourism. These proposals are examined in context of the schemes guidelines and financial assistance is extended for projects subject to fulfilment of the stipulated provisions and availability of funds.
