(a) to (d): Ministry of Skill Development and Entrepreneurship (MSDE) does not have any specific scheme to set up Skill University in States/UTs. However, the States/UTs may establish Skill Universities with an objective to promote vocational education and training in an integrated and holistic manner with general education so as to ensure pathways for progression and mobility across forms of education and skill.

Recognising the demographic dividend that India enjoys and huge potential to reap productivity gain through skill development, Ministry of Skill Development and Entrepreneurship (MSDE), under Skill India Mission (SIM) of Government of India, delivers skill, re-skill and up-skill training through an extensive network of skill development centres / institutes under various schemes, viz. Pradhan Mantri Kaushal Vikas Yojana (PMKVY), Jan Shikshan Sansthan (JSS), National Apprenticeship Promotion Scheme (NAPS) and Craftsman Training Scheme (CTS) through Industrial Training Institutes (ITIs), to all the sections of the society across the country including Uttar Pradesh. The SIM aims at enabling youth of India to get future ready and equipped with industry relevant skills

Details of number of candidates trained and training centres set-up/engaged under the schemes of MSDE in the state of Uttar Pradesh and its Bahraich district are as follows:
