ROLE OF INDIAN EMBASSIES ABROAD

***196. SHRI BRIJMOHAN AGRAWAL**

Will the Minister of EXTERNAL AFFAIRS be pleased to state:

- (a) whether the Government maintains a record of Indian emigrants, if so, the details of the Persons of Indian Origin (PIOs) living in various countries, country-wise;**
- (b) the role of the respective Embassies and Consulates in protecting the human rights of Indian emigrants;**
- (c) the name of the country, if any, where India does not have a consulate or embassy despite settlement of huge Indian diaspora therein along with the reasons therefor; and**
- (d) whether cultural attaches have been deputed in all Indian Embassies and Consulates to protect the religious and cultural sentiments of Indian emigrants, if so, the details thereof and if not, the reasons therefor?**

BRIJMOHAN AGRAWAL**

(a) A PIO/OCI (Person of Indian Origin/Overseas Citizen of India) is a citizen/national of a foreign country who, or whose ancestor, traces their origin to India. The Government of India has introduced several initiatives aimed at strengthening ties with them. These efforts focus on reconnecting them with their cultural roots, supporting their visits to India, and extending certain privileges. Programmes like the Know India Programme (KIP) offer young PIOs a 21-day immersive experience in India to learn about the nation's development and heritage. Indian Missions abroad promote cultural engagement by supporting diaspora-led events under the Promotion of Cultural Ties with Diaspora (PCTD). Consular support is also extended to PIOs and OCIs, especially during crises.

In addition to welfare services, the Indian government offers several benefits under the OCI Scheme. OCIs enjoy lifelong multiple-entry visas, exemption from police registration, and parity with NRIs in economic,

financial, and educational sectors, with a few exceptions like agricultural land ownership. They too have advantages in employment opportunities. They also benefit from domestic pricing at national parks, monuments, and airfares. To promote intellectual engagement, research grants are offered by the Ministry of Health & Family Welfare for NRI, PIO, and OCI scholars working in priority areas in India. Together, these initiatives underscore the government's commitment to fostering a deeper, enduring connection between India and its global diaspora.

As per available inputs, the population of overseas Indians is 3,43,56,193, out of which 1,71,81,071 are Persons of Indian Origin (PIOs) and 1,71,75,122 are NRIs. The country-wise details are attached at Annexure – A.

(b) The Government accords the highest priority to the safety, protection and well-being of all Indian nationals abroad, with various mechanisms in place to address such issues. It has established such mechanisms to enable Indian nationals abroad to reach out to the Indian Missions in case they need any assistance. Indian nationals can contact the Missions/Posts through various channels like walk-in, email, social media, multilingual

24x7 emergency numbers and also grievance redressal portals like MADAD, CPGRAMS, eMigrate etc. In addition, Indian Missions/Posts abroad have established toll-free helplines, Whatsapp numbers and have launched mobile apps to enable Indian nationals contact concerned Indian Missions/Posts when in distress or in emergency situation.

To ensure safe and orderly emigration for Indian emigrant workers, the process of recruitment is done through eMigrate portal. The web-based application makes the process of emigration fully digital, transparent, safe, legal, humane, efficient, convenient and faster. A dedicated helpline and support system is also available to assist emigrants and other stakeholders to address any query/issue.

Moreover, Pravasi Bharatiya Sahayata Kendras (PBSK) have been set up in New Delhi, Dubai (UAE), Riyadh and Jeddah (Saudi Arabia) and Kuala Lumpur (Malaysia) and Kshetriya Pravasi Sahayata Kendras (KPSKs) in Kochi, Hyderabad, Chennai, Lucknow, Patna and Chandigarh to provide assistance, guidance and counseling to Indian nationals in distress.

Our Missions/Posts abroad also utilize the Indian Community Welfare Fund (ICWF) to provide the following assistance to the Indian nationals in distress on a means-tested basis:

- (i) Transportation of mortal remains to India or cremation with the consent of the family;**
- (ii) Emergency medical care;**
- (iii) Legal assistance;**
- (iv) Boarding and lodging; and**
- (v) Air passage for stranded Indians.**

Besides, the Missions in Gulf Countries have provisions for shelter home to assist Indian women in distress by providing boarding and lodging, medical treatment and arranging for their repatriation. Female workers who are stranded and are in distress can approach the Embassies at any time of the day and they are accommodated and provided all facilities till they are repatriated to India.

Further, the Government has taken several initiatives such as Pravasi Bhartiya Bima Yojna (PBBY) and Pre-Departure Orientation Training (PDOT) in ensuring that Indian migrant workers undertake safe migration, have

decent working and living conditions in destination countries, are aware of their rights and have access to various welfare schemes of the Government.

Based on MoUs signed with the GCC countries, matters related to welfare and protection of workers are taken up during regular meetings of Joint Working Groups with concerned countries. In addition, such matters are also regularly taken up with respective host governments through diplomatic channels. Further, Migration and Mobility Partnership Agreements have been signed with seven countries, which seek to enhance global employment opportunities for Indian workers while protecting their labour rights, preventing irregular migration and supporting skill development.

(c) India currently has 219 Missions and Posts abroad. All countries with significant Indian diaspora are covered.

(d) Promotion of Indian culture and development of cultural interaction with the host country is an integral part of the activities of all Indian Missions abroad. All Heads of Indian Missions and Posts abroad actively

promote awareness of Indian culture in their host countries. The Indian Council for Cultural Relations (ICCR) has 38 Cultural Centres (list attached at Annexure B). These Centres engage with the Indian diaspora, fostering a sense of community and promoting Indian culture among those living abroad. In other Missions and Posts where there are no cultural centres under the auspices of ICCR, officers in the Missions and Posts are designated to look after the promotion of Indian culture abroad and they maintain cultural connect with the Indian diaspora.
