Promotion of AYUSH Systems of Medicine

1027. Smt. Geniben Nagaji Thakor:

Will the Minister of AYUSH be pleased to state:

- (a) whether the Government is taking steps to promote AYUSH systems of medicine in the country;
- (b) if so, the details of awareness campaigns launched, wellness centres opened and training programmes undertaken during the last three years;
- (c) whether there is any plan to integrate AYUSH with mainstream healthcare services;
- (d) if so, the details thereof; and
- (e) the details of funds allocated and utilized under the National AYUSH Mission during the last two financial years?

ANSWER

THE MINISTER OF STATE (IC) OF THE MINISTRY OF AYUSH (SHRI PRATAPRAO JADHAV)

- (a) & (b) Ministry of Ayush is implementing the Centrally Sponsored Scheme of National Ayush Mission (NAM) through State/UT Governments and supporting their efforts for promotion and overall development of Ayush systems of medicine in the country. Under NAM, grant-in-aid is being provided to the State /UT Governments against their proposals received through State Annual Action Plans (SAAPs) as per the provisions of NAM guidelines. The NAM inter-alia makes provision for following activities:
- (i) Operationalization of Ayush Health & Wellness Centres (AHWCs) now renamed as Ayushman Arogya Mandir (Ayush).
- (ii) Co-location of Ayush facilities at Primary Health Centres (PHCs), Community Health Centres (CHCs) and District Hospitals (DHs)
- (iii) Upgradation of existing standalone Government Ayush Hospitals
- (iv) Upgradation of existing Government/Panchayat/Government aided Ayush Dispensaries/ Construction of building for existing Ayush Dispensary (Rented/dilapidated accommodation)/ Construction of building to establish new Ayush Dispensary

- (v) Setting up of 10/30/50 bedded integrated Ayush Hospitals
- (vi) Supply of essential drugs to Government Ayush Hospitals, Government Dispensaries and Government/Government aided Teaching Institutional Ayush Hospitals
- (vii) Ayush Public Health Programs
- (viii)Ayush Gram
- (ix)Behavior Change Communication (BCC)
- (x) Establishment of new Ayush colleges in the States where availability of AYUSH teaching institutions is inadequate in Government Sector.
- (xi) Infrastructural development of Ayush Under-Graduate Institutions and Ayush Post-Graduate Institutions/add on PG/ Pharmacy/Para-Medical Courses.

Further, Ministry of Ayush implements the Central Sector Scheme for Promotion of Information Education and Communication (IEC) in Ayush to create awareness regarding Ayush Systems of Medicine. This aims to reach out to all sections of the population across the country. This scheme provides assistance for organizing National/State Arogya Fairs, Yoga Fests/Utsavs, Ayurveda Parvs, etc. The Ministry also undertakes Multi-Media, Print Media Campaigns for creating awareness about Ayush System.

Public Health being State subject, opening of wellness centres comes under purview of respective State/UT Governments. However, under NAM, there is provision of financial assistance for operationalization of Ayush Health & Wellness Centres [now renamed as Ayushman Arogya Mandir (AAM) (Ayush)] by upgrading existing Ayush dispensaries as well as Sub Health Centres. Under NAM, as per the proposals received from States/UTs through SAAPs, 12500 AAM (Ayush) have been approved in different parts of the country and as reported by State/UT Governments all are operational. The State/UT-wise status of approved AAM (Ayush) is enclosed as **Annexure-I.**

Furthermore, Ministry of Ayush is also implementing a Central Sector Scheme namely Ayurgyan since 2021-22 having a component of 'Capacity Building & Continuing Medical Education (CME) in Ayush' under which there is a provision to support the eligible organizations across the country for training & capacity building program in the field of Ayush with the aim to encourage Ayush personnel to undergo need-based professional training and bridge the knowledge gaps. During the last three years (Year 2022-23, 2023-24 and 2024-25), various organizations have been supported to conduct 158 CME/training programmes for upgradation of knowledge of Ayush personnel under the CME component of Ayurgyan scheme.

(c) & (d) Government of India has adopted a strategy of Co-location of Ayush facilities at Primary Health Centres (PHCs), Community Health Centres (CHCs) and District Hospitals (DHs), thus enabling the choice to the patients for different systems of medicines under a single window. The engagement of Ayush doctors/ paramedics and their training is being supported by the Ministry of Health & Family Welfare under National Health Mission (NHM), while the support for Ayush infrastructure, equipment/ furniture and medicines is being provided by the Ministry of Ayush under National Ayush Mission (NAM), as shared responsibilities. The State/UT status of co-located Ayush facilities at PHCs, CHCs and DHs is furnished at Annexure-II.

(e) The details of funds allocated/released and utilized as reported by State/UT Gove under NAM during the last two financial years (2023-24 and 2024-25) is furnished at Anim.
