1064. SHRI KESINENI SIVANATH:

Will the **Minister of HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) the total number of Ayushman Arogya Mandirs (AAMs) sanctioned and operational in the country, State-wise and district-wise for Andhra Pradesh;
- (b) the amount allocated and released for AAMs, State-wise and district-wise for Andhra Pradesh;
- (c) the total number of Sub Health Centres and Primary Health Centres currently being upgraded as AAM, State-wise and district-wise for Andhra Pradesh;
- (d) the total number of sanctioned and vacant posts in operational AAMs, State-wise and district-wise for Andhra Pradesh;
- (e) the number of AAMs which have implemented robust IT systems, State-wise and district wise for Andhra Pradesh;
- (f) whether the Government has conducted any audit of the infrastructural status of operational AAMs; and
- (g) if so, the details regarding the findings of the same and if not, the reasons therefor ?

(a) to (c): As per Ayushman Arogya Mandir (AAM) portal, State/UT-wise number of AAMs operationalized across the country including Andhra Pradesh, as on 15.07.2025, is enclosed as Annexure-I. District-wise number of AAMs operationalized in Andhra Pradesh, as on 15.07.2025, is attached as Annexure-II.

Details of State/UT wise State Program Implementation Plan (SPIP) Approvals for AAMs including for Andhra Pradesh under National Health Mission (NHM) from FY 2022-23 to FY 2024-25 is attached at Annexure-III.

(d): Health Dynamics of India (HDI) (Infrastructure & Human Resources), 2022-23 is an annual publication, based on Health care administrative data reported by States/UTs. Details of sanctioned & vacant posts of health manpower in sub-health centres and Primary health Centres including AAMs in rural & urban areas of the country including Andhra Pradesh may be seen at the following link of HDI 2022-23:

(e): Operational AAMs are equipped with robust Information Technology (IT) systems to ensure efficient service delivery and data management. These systems include the necessary hardware and software infrastructure to support real-time data entry, service tracking, and reporting. Key digital platforms such as the Ayushman Arogya Mandir Portal, Health Management Information System (HMIS), e-Sanjeevani, National Programme for Prevention and Control of Non-Communicable Diseases (NP-NCD) Portal, and Reproductive and Child Health (RCH) Portal are utilized to capture various health service parameters. This digital ecosystem enables seamless monitoring, evaluation, and evidence-based planning at the facility, block, district, state, and national levels, thereby strengthening accountability and enhancing the overall efficiency of primary healthcare delivery.

(f) and (g) : Under NHM, the performance of various health programmes including AAMs is regularly assessed, through review meetings, mid-term reviews of key deliverables, field visits of senior officials, promoting performance by setting up benchmarks for service delivery & rewarding achievements etc. Various indicators of National Health Mission (NHM) have been regularly assessed through external surveys such as National Family Health Survey (NFHS) and Sample Registration System (SRS). Further, under NHM, Common Review Missions (CRM) are conducted annually to assess and monitor the progress and implementation status of various schemes.
