**RASHTRIYA GRAM SWARAJ ABHIYAN IN MADHYA PRADESH**

†1468. SMT. SANDHYA RAY:

Will the Minister of PANCHAYATI RAJ be pleased to state:

- (a) the details of the works done under Rashtriya Gram Swaraj Abhiyan (RGSA) during the last five years including Madhya Pradesh;
- (b) the details of the work done in the States and details of funds granted and spent by the Government on the scheme during the last five years, State-wise particularly in Bhind and Datia districts; and
- (c) whether the Survey of Villages and Mapping with Improvised Technology in Village Areas (SVAMITVA) scheme is being implemented by the Government in Madhya Pradesh and if so, the details thereof?

**ANSWER**

(a) & (b) The Ministry implemented the Rashtriya Gram Swaraj Abhiyan (RGSA) during 2018-19 to 2020-21 and Revamped Centrally Sponsored Scheme of Rashtriya Gram Swaraj Abhiyan (RGSA) w.e.f. financial year 2022-23 with the main objective for capacitating Panchayati Raj institutions (PRIs) through imparting training to Elected Representatives (ERs) and other stakeholders to develop their governance capabilities for leadership roles to enable the Gram Panchayats to function effectively. Under schemes funds was/were released to States/ Union territories not to Districts.

During the last five years, approximately 1.76 cr. participants were provided training, 8,134 Panchayat Bhawans were constructed, and 18,277 computers were procured by the States and Union Territories. Among the achievements, 19.06 lakhs participants were trained, 289 computers were procured, and construction of 50 Panchayat Bhawans are under progress in the State of Madhya Pradesh. State/UT-wise achievements of training, Panchayat Bhawan

construction and computer procured is at **Annexure-I**. Details of Central Share released, and fund spent by the States/UTs during the last five years is at **Annexure-II**.

(c) The Ministry is implementing Survey of Villages and Mapping with Improvised Technology in Village Areas (SVAMITVA) Scheme to provide Record of Rights to village property owners. The scheme aims to demarcate inhabited (Abadi) land in rural areas through the latest drone survey-technology through the collaborative effort of the Ministry, State Revenue Departments, State Panchayati Raj Departments and Survey of India. The scheme has multiple objectives enabling bank loans against property card, reducing property related disputes and comprehensive village level planning. As on 24<sup>th</sup> July 2025, drone survey has been completed in 3.26 lakh villages, 2.63 crore property cards have been prepared for 1.73 lakh villages. Drone survey is saturated in Andhra Pradesh, Madhya Pradesh, Uttar Pradesh, Chhattisgarh, Delhi, Kerala and Ladakh. The scheme has been saturated in Haryana, Uttarakhand, Puducherry, Goa, Tripura, Dadra Nagar Haveli Daman, Lakshadweep and A&N Island. Under SVAMITVA Scheme a network of 567 Continuously Operating Reference Stations (CORS) are established.

#### **Status of SVAMITVA Scheme in Madhya Pradesh**

- Drone survey has been completed in all inhabited villages (43,014) of the State
- 46.1 lakh property cards have been prepared for 36 thousand villages
- Under SVAMITVA Scheme, 90 CORS are established in the State.
