**OUTSTANDING PAYMENT UNDER MGNREGS**

**1599. Shri LaljiVerma:**

**Will the Minister of RURAL DEVELOPMENT be pleased to state:**

- (a) whether the payment for material head under Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) in Ambedkar Nagar and Ayodhya districts for the financial year 2023-24, 2024-25, 2025-26 is pending, if so, the details thereof;**
- (b) whether the Government proposes to pay the outstanding amount; and**
- (c) if so, the time by which outstanding amount paid?**

**(a)to (c): Under Mahatma Gandhi National Rural Employment Guarantee Scheme (Mahatma Gandhi NREGS) fund release to the States/UTs is a continuous process. For release of fund for Material component, States/UTs are required to furnish fund release proposals to the Government of India. The Central Government releases funds periodically in two tranches with each tranche consisting of one or more installments, keeping in view the “agreed to” Labour Budget, demand for works, opening balance, pace of utilization of funds, pending liabilities, overall performance and subject to submission of relevant documents by the States/UTs.**

**The Central government releases material funds to the State Government which in turn releases the same to Districts. The Central Government does not release material funds directly to the Districts.**

**In the current Financial Year 2025-26 (as on 23.07.2025) an amount of Rs. 6068.58 crore has been released to the State of Uttar Pradesh, including full pending Wage Liabilities and 50% of Material Liabilities of the previous financial year. There is no pending liability for materiel component in respect of Uttar Pradesh for FY 2023-24.**

**Total expenditure incurred under the scheme in Ambedkar Nagar and Ayodhya districts of Uttar Pradesh during the last two financial year and current financial year 2025-26 (as on 24.07.2025) are given below:**
