- (a): Yes, the Government has initiated the National Industrial Corridor Development Programme (NICDP) to develop new industrial cities with sustainable infrastructure & make available Plug and Play infrastructure at the plot level.

A Special Purpose Vehicle (SPV), namely “Kerala Industrial Corridor Development Corporation Limited” has been incorporated for the implementation of the project.
