Will the **Minister of HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) the details of the health facilities selected for Kayakalp incentives, State-wise and district-wise for Andhra Pradesh;
- (b) the details of the amount of incentive allocated and disbursed under the said initiative over the last five years, State-wise and year-wise;
- (c) the number of workshops and trainings organized over the last five years under the scheme, State-wise and year-wise; and
- (d) the details of the themes currently selected under the Kayakalp scheme?

(a) State/UT-wise number of health facilities selected for Kayakalp incentives is at Annexure-I. As per Government of Andhra Pradesh, a total of 5323 health facilities have been selected for Kayakalp category. District-wise details of health facilities are attached as Annexure-II.

(b) State/UT-wise details of State Programme Implementation Plan (SPIP) approvals and expenditure for Kayakalp Activities under National Health Mission (NHM) for the financial years 2020-21 to 2024-25 is at Annexure-III.

(c) Data related to workshops and trainings organized by various States/UTs are not maintained centrally.

(d) Under the Kayakalp Scheme, the assessment is conducted across eight mandatory themes, which have been uniformly applied to all levels of healthcare facilities. These themes are:

1. Hospital / Facility Upkeep
2. Sanitation and Hygiene
3. Waste Management
4. Infection Prevention and Control
5. Hospital Support Services
6. Hygiene Promotion
7. Cleanliness Beyond Hospital/Facility Boundary Wall
8. Eco-friendly Facility (applicable to District Hospital or equivalent and Community Health Centre only)
