Will the Minister of CULTURE be pleased to state:

- (a) the details along with list of complaints from 01.01.2020 regarding illegal constructions or encroachments in protected and regulated zones of State and centrally protected monuments in Goa such as Old Goa, Harvalem, Aguada including monument/site name, location of illegality, complaint date and actions taken;
- (b) whether the heritage bye-laws, as required under Section 20E of the Ancient Monuments and Archaeological Sites and Remains (AMASR) Act, 1958, and 2011 Rules (as amended) have been prepared and notified for protected monuments and areas in Goa, if so, the details thereof; and
- (c) the details along with list of all applications and permissions for repair, construction or other activities in prohibited and regulated areas around protected monuments in Goa approved by the National Monuments Authority, including monument name, area (prohibited/regulated), project size, location (survey number and village), applicant name, date and clearance date?
