Will the Minister of SOCIAL JUSTICE AND EMPOWERMENT be pleased to state:

- (a) the total number of beneficiaries who have received training under the Pradhan Mantri Dakshta Aur Kushalta Sampann Hitgrahi (PM-DAKSH) Yojana since its inception;
- (b) the total funds allocated, released and utilised for the PM-DAKSH Yojana in each financial year since the scheme was launched, year and State/UT-wise; and
- (c) the total number of trained beneficiaries who have been successfully placed after completing their training under the scheme, year and State/UT-wise?

ANSWER

- (a): The total number of beneficiaries who have received skill training under Pradhan Mantri Dakshta Aur Kushalta Sampann Hitgrahi (PM-DAKSH) Scheme is 1,87,305.
- (b): As PM-DAKSH Scheme is a Central Sector Scheme, no funds are allocated and released State/UT wise under the Scheme. The Department releases funds to three Corporations, National Scheduled Castes Finance & Development Corporation (NSFDC), National Backward Classes Finance & Development Corporation (NBCFDC) and National Safai Karamcharis Finance & Development Corporation (NSKFDC) under the Scheme. The Scheme has been approved by Standing Finance Committee for a period of five years, from 2021-22 to 2025-26. The details of funds allocated and released year-wise by the Department are as under:-

(c): PM-DAKSH Scheme is implemented by three Corporations, NSFDC, NBCFDC and NSKFDC for different target groups. The total number of trainees got placement after receiving training till now is 73,150. The details of trained beneficiaries who have been successfully placed after completing their training under the scheme, year and State/UT-wise with regard to each Corporation is placed at **Annexure-I**.
