SVAMITVA SCHEME

4220. DR. SHASHI THAROOR:

Will the Minister of PANCHAYATI RAJ be pleased to state:

- (a) the details of the number of farmers who have received their deeds under the Survey of Villages Abadi and Mapping with Improvised Technology in Village Areas (SVAMITVA) scheme, State-wise;
- (b) whether the implementation of SVAMITVA schemes in tribal societies has faced any criticism, if so, the details thereof; and
- (c) whether the Ministry has devised a plan to overcome this problem, if so, the details thereof;
- (d) whether the Government has conducted an impact assessment of this scheme and if so, the details thereof and if not, the reasons therefor?

ANSWER

THE MINISTER OF STATE FOR PANCHAYATI RAJ

(PROF. S. P. SINGH BAGHEL)

- (a) SVAMITVA Scheme aims to provide Record of Rights to villages property owners in rural inhabited (Abadi) farmers. As on date, 2.63 Crore property cards have been prepared in 1.73 lakh villages. State/UT wise details annexed at **Annexure I**.
- (b) No, Sir; the Ministry has not come across any criticism regarding the implementation of the SVAMITVA scheme in tribal areas.
- (c) In view of (b) above, the question does not arise.
- (d) Yes sir, the Ministry of Panchayati Raj had undertaken impact evaluation of SVAMITVA Scheme in pilot phase (2020-2021) in six states namely Haryana, Karnataka, Madhya Pradesh, Maharashtra, Uttar Pradesh and Uttarakhand through National Institute of Public Finance and Policy (NIPFP). The evaluation study emphasized the need for SVAMITVA Scheme in providing property rights and creating accurate land records for inhabited areas while enabling rural property owners to monetize residential assets. Therefore, the evaluation study of the pilot states concluded that SVAMITVA Scheme needs to be scaled up and rolled out across the country.
