#### **LINK ROADS NETWORK**

NO. 4664. SMT. D K ARUNA:

Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) whether missing links of roads in the country have been identified through comprehensive surveys conducted from time to time in each State and an efficient network design has been recommended and prepared in coordination with various States and Unified Metropolitan Transport Authorities (UMTAs);
- (b)if so, whether any Comprehensive Mobility Plan (CMP) has been prepared and if so, the details thereof;
- (c)whether the Union and State Governments and other institutions have signed any Memorandum of Understanding (MoUs) with each other for integrating Artificial Intelligence (AI) into improving road networks and easing traffic congestion; and
- (d)if so, the details thereof and the steps taken to achieve the goal of 'Viksit Bharat-2047' by identifying missing or critical roads across the country, State/UT-wise, including the areas of Guntur, Palnadu, Vijayawada, Nalgonda, Bhongir, Karimnagar, Khammam and Nellore districts of Andhra Pradesh and Telangana along with the funds sanctioned and spent so far?

#### **ANSWER**

# THE MINISTER OF STATE IN THE MINISTRY OF HOUSING AND URBAN AFFAIRS (SHRI TOKHAN SAHU)

(a) National Highways Authority of India has reported that Development of National Highways is a continuous process depending on project prioritisation in consultation with economic sector Ministries and other stakeholders including States and subject to availability of resources. Government receives proposals from various State Governments / Union Territories (UTs) from time to time, for declaration / upgradation of State roads, including State Highways (SHs), as new National Highways (NHs). Decisions are taken based on the broad principles of declaration of NHs, requirement of connectivity, traffic density, inter-se priority and synergy with PM GatiShakti National Master Plan (NMP). Further, consultation with State Government is also done to mitigate the regional imbalance related to road network/density and ensuring last mile connectivity in all parts of the country.

- (b) This Ministry has received proposals for seeking Central Financial Assistance (CFA) for the preparation of Comprehensive Mobility Plan (CMP) from various State Governments/Implementing Agencies. The detail of proposals for CFA sanctioned during the last five years is provided in Annexure-I.
- (c) 'Urban Planning' is a State subject and hence respective State Governments are responsible for signing Memorandum of Understanding (MoUs), if any, with institutions for integrating Artificial Intelligence (AI) so as to improve road networks and easing traffic congestion. This Ministry has not signed any MoU for this purpose.
- (d) NHAI has reported that in respect of Andhra Pradesh, four number of projects for expansion/ upgradation of National Highways in Andhra Pradesh have been sanctioned. The details of projects along with the districts in which these projects passes through are enclosed at Annexure-II.

In respect of Telangana, five number of projects for expansion/ upgradation of National Highways in the Telangana districts of Khammam & Karimnagar have been sanctioned. The details of projects along with the districts in which these projects passes through are enclosed at Annexure-III.
