#### **TOURIST INFLOW IN JAMMU & KASHMIR**

#### 48. SHRI TEJASVI SURYA:

Will the Minister of TOURISM be pleased to state:

- (a) the total number of domestic and international tourists visited Jammu and Kashmir during the last five years and the current year;
- (b) whether the Swadesh Darshan Scheme has had a measurable impact on the tourist inflow in the region and if so, the details thereof;
- (c) the list of heritage sites and tourist destinations in Jammu & Kashmir that have been included under the said scheme, along with the year of inclusion; and
- (d) the number of direct and indirect employment opportunities generated in Jammu & Kashmir under the said scheme during the last five years and the current year?

#### **ANSWER**

### THE MINISTER OF TOURISM (SHRI GAJENDRA SINGH SHEKHAWAT)

(a): The number of domestic and foreign tourist visits in Jammu & Kashmir during the last five years is given below:

(b) to (d): The Ministry of Tourism, under the Swadesh Darshan Scheme, sanctioned a total of six (6) projects in the year 2016-17 for the Union Territory of Jammu and Kashmir, with a total sanctioned cost of ₹519.58 crore. All these projects have since been physically completed. The list of the projects sanctioned under Swadesh Darshan scheme in UT of Jammu & Kashmir is placed at the annexure.

The Ministry has not undertaken any formal study to date to assess the extent of direct and indirect employment generated in the region under the Scheme during the last five years.
