**ASSISTANCE UNDER PMSSY AND NHM TO KOTTAYAM MEDICAL COLLEGE**

**972. SHRI K SUDHAKARAN:**

Will the **Minister of HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) the details of Union Government assistance under PMSSY and NHM for infrastructure upgrades at Kottayam Medical College Hospital in the State of Kerala;
- (b) whether the Ministry was aware of the dilapidated condition of the collapsed building, reported since 2013, if so, the details thereof;
- (c) the steps taken to ensure structural audits of old hospital buildings across Kerala under central schemes;
- (d) the measures taken to enhance Centre-State coordination to prevent such incidents; and
- (e) the financial aid provided to the family of the deceased and injured in the collapse of the buildings of the said hospital?

**ANSWER  
THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE  
(SMT. ANUPRIYA PATEL)**

(a) to (e): Government Medical College (GMC) at Kottayam, Kerala is a State funded medical college. The construction & management of the college comes under the purview of the State Government of Kerala. Further, Public Health and Hospitals is a State subject and the responsibility for strengthening of healthcare system lies with respective State/UT Governments. However, Ministry of Health and Family Welfare, Government of India provides financial and technical support to the States/UTs. under National Health Mission (NHM), to strengthen their healthcare systems based on the Programme Implementation Plans (PIPs) submitted by the States/UTs within their overall resource envelope. The Government of India provides approval for the proposal in the form of Record of Proceedings (RoPs) as per norms and available resources. The details of Infrastructure projects under taken under NHM in Government Medical College Kottayam is attached as an Annexure.
