- (a) whether the Government has data on the export of arecanut from the country during the last ten years;
- (b) if so, the details thereof along with the export volume (in metric tonnes), export value (in USD million), and INR equivalent (in crores) during the said period, State-wise;
- (c) the details of the major destination countries for arecanut exports from India;
- (d) the steps taken by the Government to promote arecanut exports and improve market access for Indian farmers and exporters; and
- (e) whether the Government has data on arecanut imports into India during the last ten years, if so, the details thereof along with the volume and value (in metric tonnes and USD/INR) of imports, including major source countries?

The government maintains record of total exports from India. The data for State wise exports of Arecanut is not maintained, in absence of validation by the DGCIS (Directorate General of Commercial Intelligence and Statistics), as these are based on the state-of-origin code reported by the exporters in the shipping bills.

In the ten-year period between 2015-16 to 2024-25, the exports of Arecanut have grown in terms of value, by 35.69% in terms of Rupees and by 6.2% in terms of US dollars.

(d) The Department of Commerce through the Agricultural and Processed Food Products Export Development Authority (APEDA), provides financial assistance for promotion of its Scheduled products, including Arecanut, through its Financial Assistance Scheme (FAS), in

three components: (i) Development of Export Infrastructure, (ii) Quality Development, (iii) Market Development. Scheme guidelines are available at https://apeda.gov.in/FinancialAssistanceSchemes.

For the promotion of Arecanut exports, APEDA facilitated participation of Arecanut exporters in World Food India and its Reverse Buyer seller meet, in September 2025. APEDA also organised training-cum-capacity building program with the Horticulture Department Karnataka, in Chitradurga, Karnataka, in September 2025, where Arecanut farmers, Farmers Producer Organisations (FPOs) and other stakeholders participated.
