- (a) whether it is a fact that majority of the member posts at the National Medical Commission (NMC) remained vacant for a considerable period of time and if so, the details thereof;
- (b) the total number of members of the Commission and the total vacant posts of Members at present, along with the date since when the seats are vacant; and
- (c) the reasons for not filling up the vacancies and the measures being taken to fill up the vacancies before the next academic session gets started?

(a) to (c): Thirty-three (33) member posts of National Medical Commission (NMC) are notified under NMC Act, 2019. Details of twenty-eight (28) members in position and five (5) vacant posts are at Annexure. Further, nineteen (19) Part-Time Members in NMC have been selected by conducting a draw of lots on 15/07/2025 as prescribed in the Regulations framed under NMC Act, 2019.

To fill up the vacant posts, advertisements have been published in English and Hindi national daily newspapers on 31/08/2024 and 11/10/2024 inviting applications from the eligible professionals.
