**VACANT SEATS IN MEDICAL COLLEGES**

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) the number of seats available for teaching in various courses in Government and non-Government Medical Colleges/Institutes in the country as of date;
- (b) the number of applicants received for admission to various courses in these Colleges/Institutes as of date, College/Institute-wise;
- (c) whether all applicants have been admitted to these Colleges/Institutes and if so, the details thereof;
- (d) whether there are vacant seats in various courses in Government and non-Government medical colleges/Institutions;
- (e) if so, the details thereof, College/Institute-wise and course-wise;
- (f) whether the Government has taken or is planning to take any steps to fill the vacant seats in these Colleges and Institutes; and
- (g) if so, the details thereof?

**ANSWER

(a) to (c) As informed by the National Medical Commission (NMC), there are total 1,28,875 Under Graduate Seats & 80291 Post Graduate seats in Government & Private medical colleges in the country in the year 2025-26. The Government and Private college wise details of seats are at Annexure-I.

(d) to (g) Four rounds of UG Counselling 2025 for MBBS seats are completed as per Hon'ble Supreme Court of India vide order dated 16.12.2021. The Academic Session for 2025-26 has begun from 22<sup>nd</sup> September 2025. Total 72 MBBS seats in All India Quota (AIQ) remained vacant in Government/ Non-Government institutes after four rounds as per Annexure-II.
