ATM in Aspirational Districts

1172. SHRI ATUL GARG: SHRI RAJESH VERMA: SMT. SHAMBHAVI:

Will the Minister of FINANCE be pleased to state:

- (a) the number of ATMs and Micro-ATMs currently operational in the 112 aspirational districts as well as designated border districts, State/district-wise;
- (b) the details of the transactions volume and value that have been conducted through Micro-ATMs and Aadhaar-enabled Payment Systems (AePS) in aspirational districts over the last five years;
- (c) the details of the measures that have been taken by the Government to expand the deployment of ATMs and Micro-ATMs in aspirational districts;
- (d) the details of the steps taken/proposed to be taken by the Government to promote the Banking Correspondent-Sakhi model and mobile ATM vans in unbanked or underbanked villages in border and tribal districts; and
- (e) whether the Government is considering to integrate Micro-ATM services with One Nation One Ration Card and DBT-related withdrawals for enhanced convenience in remote areas, if so, the details thereof?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI PANKAJ CHAUDHARY)

(a) to (e) Details of number of ATMs in the 112 Aspirational Districts & border Districts are placed at Annexure 1 & Annexure II respectively.

Data on number of Micro-ATMs and value & volume of transactions conducted through Micro-ATMs including Aadhaar-enabled Payment Systems (AePS) in Aspirational Districts is not centrally maintained.

As per the Reserve Bank of India (RBI) policy on 'Rationalization of Branch Authorization Policy', Banks set up onsite/offsite Automated Teller Machines (ATMs) at centres/places identified by them. Further, banks also deploy mobile ATM vans in unbanked or underbanked villages in border and tribal districts based on the operational feasibility.

Ministry of Rural Development (MoRD) has informed that various steps relating to identification, training, capacity building, certification, financing of equipment, providing them with overdraft account etc. are being taken regularly to promote the Business Correspondent-Sakhi (BC Sakhi) model. BC Sakhis are also provided with an honorarium of Rs.24,000 for maximum period of six months.

Further, the Department of Food and Public Distribution has informed that there is no consideration of integration of Micro-ATM services with One Nation One Ration Card and DBT-related withdrawals.
