IMPLEMENTATION OF ATMA SCHEME

1491. SHRI MADDILA GURUMOORTHY:

Will the Minister of AGRICULTURE AND FARMERS WELFARE कृषि और किसान कल्याण मंत्री be pleased to state:

- (a) the total funds allocated and released under the Agricultural Technology Management Agency (ATMA) scheme to various states during the last three years;
- (b) the amount of funds allocated and utilized specifically in Andhra Pradesh and Tirupati district under the scheme during the same period;
- (c) the major activities undertaken under the ATMA Scheme in Andhra Pradesh and Tirupati district, including capacity-building, training, demonstrations and exposure visits for farmers;
- (d) whether there has been any impact assessment of the scheme in the region to evaluate its effectiveness in improving agricultural practices; and
- (e) whether the Government plans to expand or revise the scheme to address the specific needs of farmers in districts like Tirupati, and if so, the details thereof?

ANSWER

THE MINISTER OF STATE FOR AGRICULTURE AND FARMERS WELFARE

- (a): State-wise details of allocation and release of funds during last three years under Agricultural Technology Management Agency (ATMA) Scheme is enclosed at **Annexure-I**.
- (b): Details of the amount of funds allocated and utilized in Andhra Pradesh and Tirupati district under ATMA scheme during last three years is enclosed at **Annexure-II**.
- (c): The major activities undertaken under the ATMA Scheme in Andhra Pradesh and Tirupati district, including capacity-building, training, demonstrations and exposure visits for farmers are enclosed at **Annexure-III**.

(d) & (e): Third party evaluation and Impact assessment study of the Scheme is being conducted periodically to evaluate its effectiveness in improving agricultural practices and the suggestions broadly indicates: -

- Farm Demonstrations and Farm Schools activities of ATMA scheme have a good learning impact on farmers and the production is also increasing. Hence these activities should be retained while one-day farmer training should be replaced with three-days training.
- Farmer Interest Groups (FIGs)/Commodity Interest Groups (CIGs)/Food Security Groups (FSGs) mobilized under ATMA scheme is working as building blocks for formation of Farmers Producer Organizations (FPOs).
- Extension activities should be taken up in the National priority areas/ themes viz. post-harvest management, surplus management, climate resilient agriculture, judicious use of fertilizers, horticulture based farming system, INM, IPM, etc.

These recommendations have already been incorporated in ATMA Guidelines, 2025 for improvement of the scheme and to address the specific needs of the farmers.
