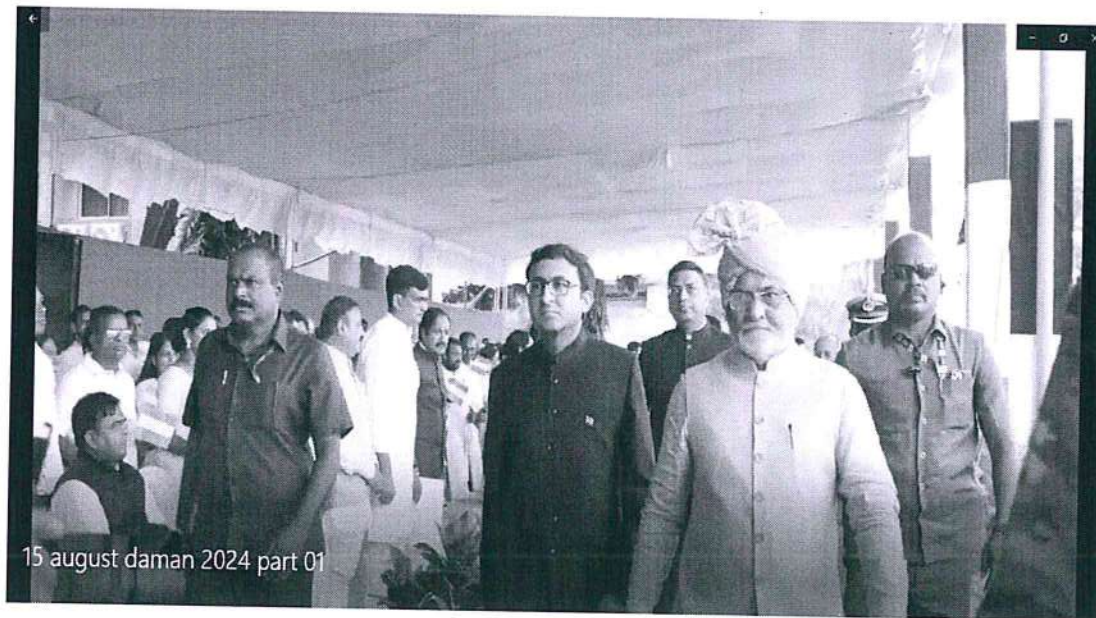

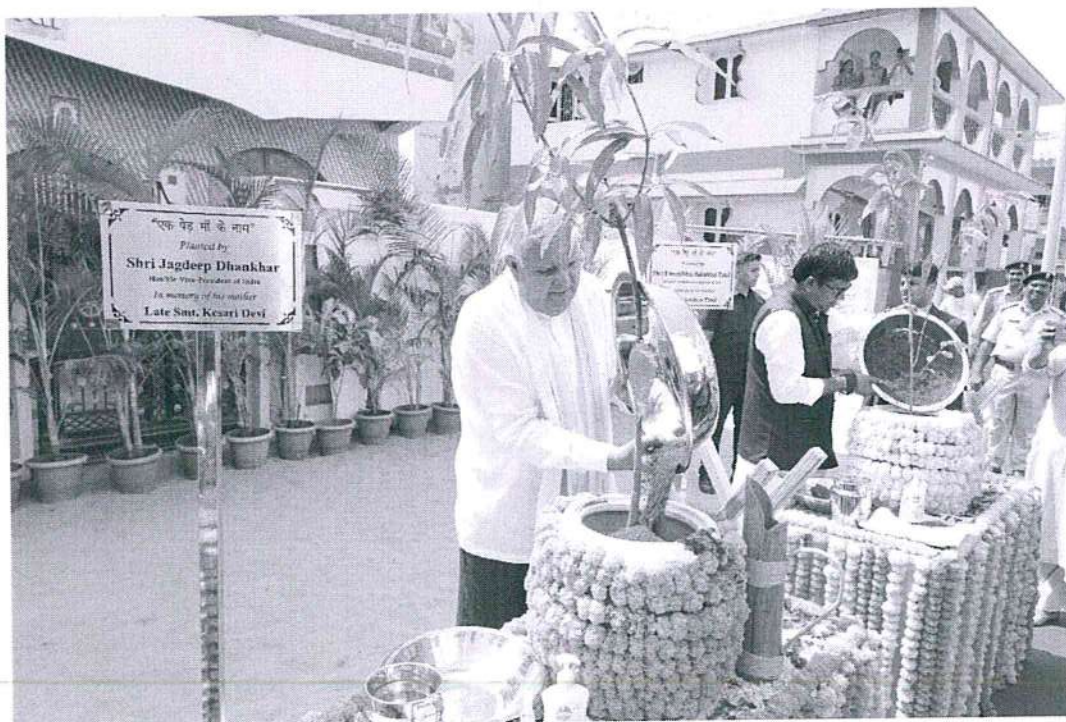

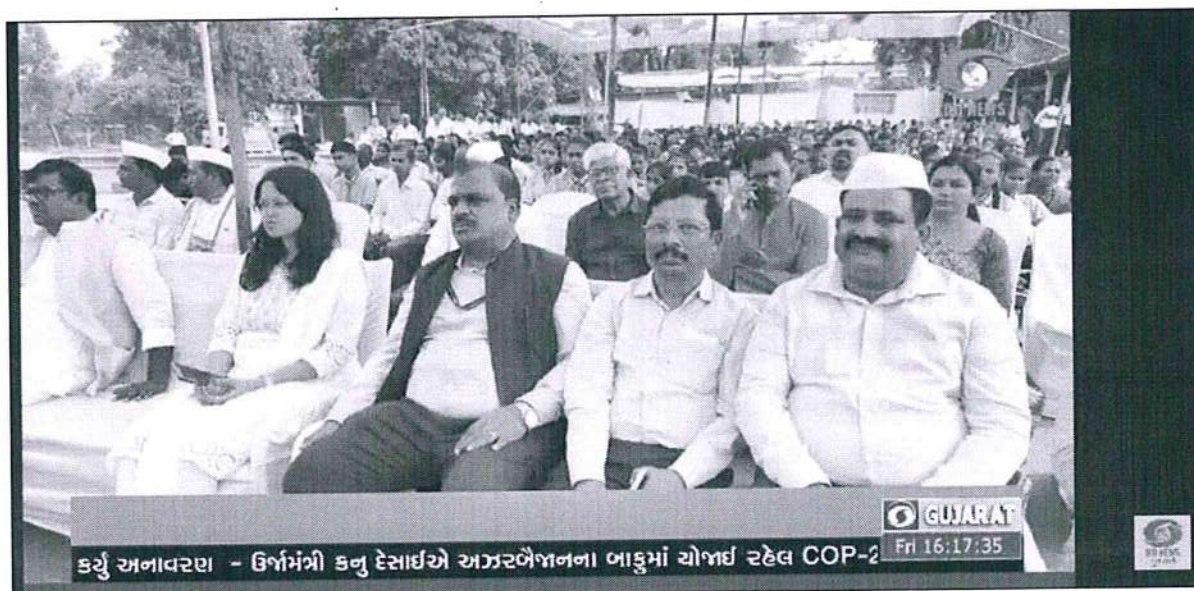

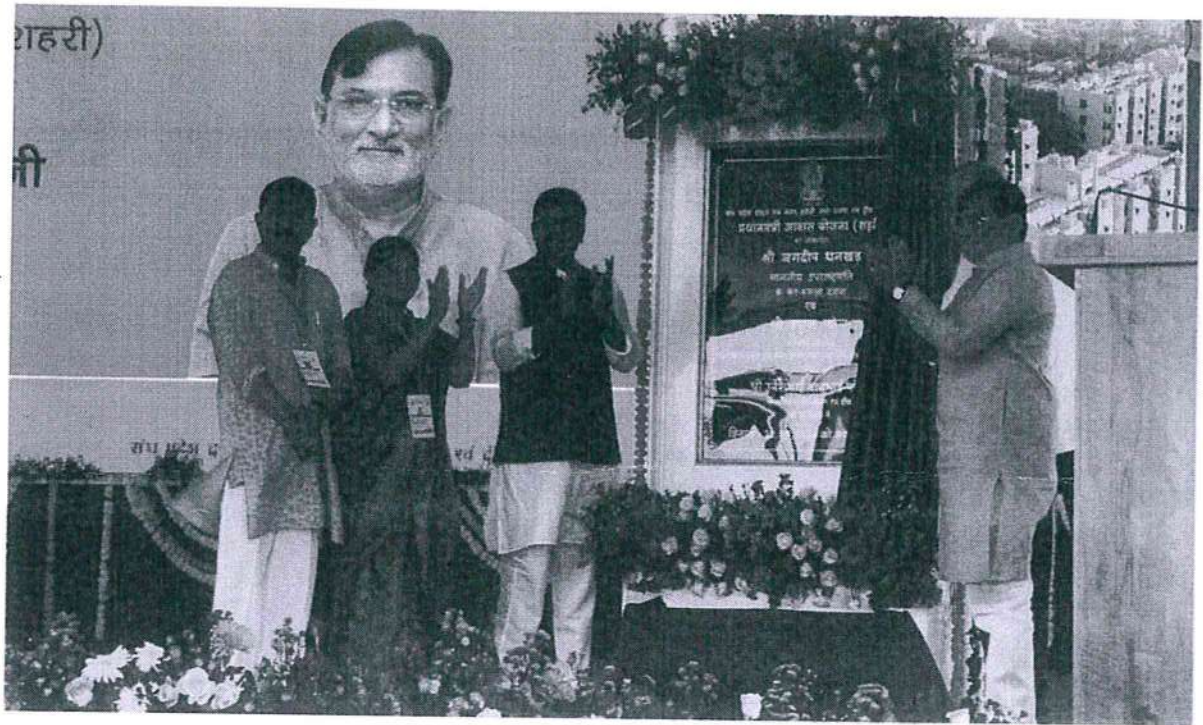

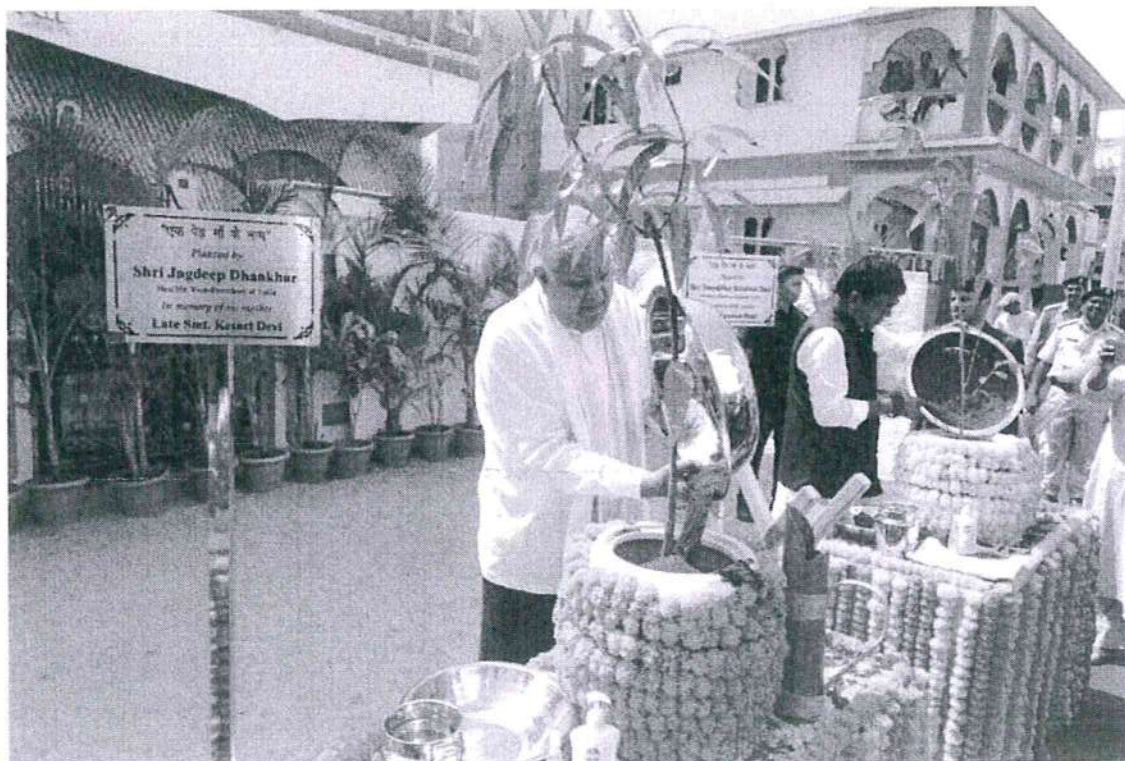


Photo 04: Tree Plantation at Diu during the visit of Hon'ble VP at Diu in September 2024
