MODERNISATION OF ROADS AND NATIONAL HIGHWAYS

1965. SHRI DEEPENDER SINGH HOODA:

Will the Minister of ROAD TRANSPORT AND HIGHWAYS

be pleased to state:

(a) the details of funds allocated, released and utilised for the modernisation of roads and National Highways during the last ten financial years, year-wise including the current financial year in Haryana;

(b) whether the Government has prepared any time-bound roadmap for the modernisation of roads and National Highways across the country and if so, the details thereof and if not, the reasons therefor; and

(c) the components included under modernisation such as strengthening, resurfacing, safety features, lane improvement, climate-resilient materials and technology-based maintenance?

ANSWER

(a) Year-wise details of expenditure incurred towards development and maintenance of NHs including modernization of NHs in the State of Haryana during the last ten financial years and current financial year are at Annexure-I.

Government also allocates and releases funds to the State Governments / UTs, including for the State of Haryana, for development and maintenance of State Roads under the Central Road & Infrastructure Fund (CRIF) Scheme as per the provisions of the amended CRIF Act, 2000. Year - wise details of accrual and release of funds for development and maintenance of State roads under CRIF Scheme in the State of Haryana during the last ten financial years and current financial year are at Annexure-II.

(b) and (c) Development and maintenance of NHs is a continuous process. Works on NHs, including construction of high speed corridors, capacity augmentation to two / four / six / eight lane standards of existing NHs, strengthening, resurfacing, rectification of black spots and other road safety related engineering improvement works, rehabilitation / reconstruction of bridges and other structures thereon with focus on resilient construction, are accordingly taken up based on the traffic density, connectivity requirement, condition of the road and synergy with PM Gati Shakti National Master Plan (NMP). At present, 1,208 NHs projects in 27,859 km length costing ₹7.68 Lakh Crore are under construction in the country.

Use of technology is inbuilt in construction, maintenance and monitoring system, e.g. Automated & Intelligent Machine-aided Construction in construction, Mobile Quality Control Van for regular testing during construction and uses of Network Survey vehicle for road surface analysis, Drone imaging analytics for checking the quality of maintenance works.
