### **DEVELOPMENT OF GREEN CORRIDORS**

#### NO. 2030. SHRI UTKARSH VERMA MADHUR:

Will the Minister of Housing and Urban Affairs be pleased to state:

- (a) whether the Government proposes any plan to develop green corridors in cities to protect biodiversity and promote socio-economic aspects and if so, the details thereof; and
- (b) the number of cities having green corridors, State-wise?

#### **ANSWER**

# THE MINISTER OF STATE IN THE MINISTRY HOUSING AND URBAN AFFAIRS (SHRI TOKHAN SAHU)

(a) & (b): As per 12th Schedule of the Constitution of India, Urban Planning including town planning is the function of Urban Local Bodies (ULBs)/ Urban Development Authorities. Government of India supplements the efforts of the States through schematic interventions/ advisories.

The Ministry of Housing & Urban Affairs (MoHUA), Government of India has issued Urban and Regional Development Plan Formulation and Implementation (URDPFI) Guidelines, 2014 (https://mohua.gov.in/upload/uploadfiles/files/URDPFI%20Guidelines%20Vol% 20I(2).pdf). The Chapter - 5 "Urban Planning Approach" of URDPFI guidelines 2014 deals with Green City.

Under Atal Mission for Rejuvenation and Urban Transformation (AMRUT) and AMRUT 2.0, the States/ Union Territories (UTs) have taken up projects for development of green spaces and parks. Under AMRUT, States/UTs have taken up 2,529 park projects worth ₹1606.31 crore and 5,271 acre of green spaces have been developed so far. Under AMRUT 2.0, 1669 Park projects with total cost of ₹1,089.31 crore, covering 13,707.64 acres of green spaces have been approved so far by MoHUA. The Statewise details of parks projects under AMRUT and AMRUT 2.0 are given in ANNEXURE-I.

Further, one of the thrust area of AMRUT was creation of pedestrian, non-motorized transport facilities. Under AMRUT, 430 km of pedestrian walkways and 43 km of dedicated cycle track have been developed.

Under the City Investments to Innovate, Integrate and Sustain (CITIIS) 1.0 program, a sub-component of the Smart Cities Mission, a Green Mobility Corridor has been developed in Hubballi Dharwad, Karnataka. A grant of ₹115.68 Cr has been provided to Hubballi Dharwad Smart City Ltd for this project. The project focuses on the rejuvenation of the Unkal Nala, the 9.25-kilometre-long drainage channel in the city, from being a mere stormwater drain to a developed, holistic space for the community. This corridor development also provides an opportunity for connecting the green corridor project to the major roads in the city passing through this Unkal Nala thereby creating a network of Non-Motorised Transport (NMT) corridors in the city.
