**HOSPITALS EMPANELLED UNDER AB-PMJAY**

**2125. ADV PRIYA SAROJ:**

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) the number of hospitals empanelled under Ayushman Bharat-Pradhan Mantri Jan Arogya Yojana (AB-PMJAY) in the country during the last five years (2020–21 to 2024–25), for public and private hospitals-wise;
- (b) whether the Government has data of the number of empanelled hospitals for each of above mentioned period along with the number of hospitals that remained active and those that were inactive, suspended or de-empanelled in the country, State-wise;
- (c) the number of hospitals that exited the PMJAY network during the said period along with the key reasons recorded for withdrawal or de-empanelment of the same;
- (d) whether any States or Union Territories in the country have shown decline or stagnation in private hospital empanelment during the last five years; and
- (e) whether the Ministry has conducted any national review of service capacity, claim settlement efficiency and beneficiary access among empanelled hospitals and if so, the major findings thereof?

(a) to (e): As on 31.10.2025, more than 32,403 hospitals are empanelled under Ayushman Bharat - Pradhan Mantri Jan Arogya Yojana (AB-PMJAY). The details of number of hospitals empanelled under AB-PMJAY in the last five years are as below:

Financial Year	Public hospitals	Private hospitals
2020-21	9,775	5,981
2021-22	10,921	7,512
2022-23	12,143	9,103
2023-24	15,735	12,018
2024-25	16,338	14,496

The number of private hospitals empanelled under AB-PMJAY has been progressively increasing. The empanelment of private hospitals is entirely voluntary under the scheme. As on 15.11.2025, 1184 hospitals have been de-empanelled and 411 hospitals have been suspended by the States/UTs. Further, regular review meetings are held to take stock of the progress with regard to the claims. Besides, capacity building activities are also organised for settlement of claims. Under AB-PMJAY, Pradhan Mantri Arogya Mitras are deployed at empanelled hospitals to guide the scheme beneficiaries and provide information related to treatment. PMJAY kiosks are set up in these hospitals as the first point of contact for facilitating awareness and overall support of beneficiaries. In addition to this, beneficiaries can call to 24x7 call centre (14555) for any assistance/queries.
