**TREATMENT OF PATIENTS UNDER AYUSHMAN BHARAT SCHEME**

**†2160. SHRI PATEL UMESHBHAI BABUBHAI:**

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) the total number of patients who have received treatment under the Ayushman Bharat scheme in the Union Territory of Dadra and Nagar Haveli & Daman and Diu (DNH & DD) during the last five years, district-wise;
- (b) the details of the total cost of the treatment of patients under the Ayushman Bharat Yojana borne by the Union Government and the UT of DNH & DD administration during the last five years;
- (c) the number of patients from the UT of DNH & DD who have received treatment under the Ayushman Bharat Scheme in hospitals situated outside the UT during the last five years;
- (d) whether the UT of DNH & DD Administration have to pay any outstanding dues to the hospitals located in Gujarat and other States across the country; and
- (e) if so, the amount of such outstanding dues along with the reasons therefor?

(a) and (b): The district-wise details of total number of patients who have received treatment under Ayushman Bharat - Pradhan Mantri Jan Arogya Yojana (AB-PMJAY) and the amount involved therein in the Union Territory of Dadra and Nagar Haveli & Daman and Diu (DNH & DD) during the last five years are at **Annexure**.

(c): 9458 hospital admissions have been authorized under AB-PMJAY in the hospitals situated outside the UT of DNH & DD during the last five years.

(d) and (e): Under the scheme, settlement of claims is an ongoing process and claims are settled by respective State Health Agencies. Portability (outside the State) treatments are paid by beneficiary's State/UT. National Health Authority has laid down guidelines for payment of claim to hospitals within 15 days of claim submission for the intra-state hospitals (hospitals located within State) and within 30 days in case of portability claims (hospitals located outside State).
