UPI Fraud Cases Resolved

2364. SHRI ABHISHEK BANERJEE:

Will the Minister of FINANCE be pleased to state:

- (a) the number of UPI fraud cases resolved within seven and thirty days respectively, State-wise;
- (b) the percentage of chargeback cases resulting in successful recovery to customers;
- (c) the comparative performance of banks and applications in processing such fraud resolutions; and
- (d) the timeline for publication of anonymised UPI micro-data to improve transparency and accountability?

Answer

- (a) & (b) The Reserve Bank of India (RBI) and National Payments Corporation of India (NPCI) have informed that state-wise details for Unified Payments Interface (UPI) fraud cases are not maintained by them. However, overall 22 percent of the reported fraud cases were acted upon within seven days and 92 percent within thirty days (by way of recovery or rejection) during April - September 2025. Further, 6 percent of the fraud chargebacks have been successfully recovered.
- (c) The comparative performance of the top 15 beneficiary banks as reported by RBI & NPCI is attached as Annexure - I
- (d) NPCI has informed that the anonymised UPI micro-data is published on its official website under "Ecosystem statistics for UPI" & "Product statistics for UPI" sections.
