STATUS OF INDUSTRIAL CORRIDORS IN UTTAR PRADESH

2573. SHRI ANURAG SHARMA:

Will the Minister of **COMMERCE AND INDUSTRY** be pleased to state:

- (a) the number of industrial projects currently approved under the Delhi–Mumbai Industrial Corridor (DMIC) and the Uttar Pradesh Defence Industrial Corridor, along with their present status of implementation;
- (b) whether land acquisition, investor mobilisation, and infrastructure development under the Uttar Pradesh Defence Corridor, particularly in the Bundelkhand region, are progressing as per the prescribed timelines, if so, the details thereof;
- (c) if not, the key bottlenecks identified, including issues related to land acquisition, environmental clearances, investor commitments, or coordination with State authorities;
- (d) the steps taken by the Government to resolve these challenges and accelerate project execution, including fast-tracking approvals, extending administrative support and promoting investor outreach; and
- (e) whether any monitoring mechanism has been established to ensure regular review of progress in the Bundelkhand nodes of the Defence Corridor, if so, the details thereof?

- (a):** The number of industrial projects approved under the National Industrial Corridor Development Programme (NICDP), under the Delhi–Mumbai Industrial Corridor (DMIC), and the Uttar Pradesh Defence Industrial Corridor, along with their present status, is as follows:

i. Approved Projects under the Delhi–Mumbai Industrial Corridor (DMIC):

- ii. The Government of Uttar Pradesh has reported that Uttar Pradesh Defence Industrial Corridor (UPDIC) spans over six nodes, viz., Aligarh, Agra, Kanpur, Lucknow, Jhansi, and Chitrakoot:
- Total land acquired (in Ha): 2040.1513
 - Allotment-62
 - Land allotted: 977.54 Ha
 - Likely employment: 14256
 - Investment (proposed by industries): INR 11997.45 Cr

(b) to (d): The Bundelkhand region has two nodes, Jhansi & Chitrakoot. The land required for the node has been fully procured. 571.09 hectares of land has been allotted to potential investors. ₹506.89 crore funds are approved for development of infrastructure works.

(e): A structured multi-tier monitoring mechanism is established to review the progress of the Bundelkhand nodes. That includes -

- Regular review meetings chaired by senior officials of the State Government and the UPDIC officers.
- Monthly progress tracking covering land, infrastructure and investor milestones, and submission of periodic reports.
