## PM-KISAN IN ANDHRA PRADESH

2584. SHRI LAVU SRI KRISHNA DEVARAYALU: SHRI G M HARISH BALAYOGI:

Will the Minister of AGRICULTURE AND FARMERS WELFARE कृषि एवं किसान कल्याण मंत्री be pleased to state:

- (a) the number of farmers benefited under the Pradhan Mantri Kisan Samman Nidhi (PMKISAN) Scheme in Andhra Pradesh since its inception, year-wise and district-wise, especially in Palnadu and Konaseema districts;
- (b) the amount of funds sanctioned, released and disbursed to beneficiaries in Andhra Pradesh under the Scheme since inception, year-wise and district-wise, especially in Palnadu and Konaseema districts:
- (c) the details regarding pending or delayed installments, district-wise in Andhra Pradesh, especially in Palnadu and Konaseema districts;
- (d) the number of farmers in Andhra Pradesh found ineligible or whose benefits were withheld due to data discrepancies/Aadhaar seeding issues/other reasons and action taken in this regard district-wise;
- (e) the steps to improve beneficiary verification, grievance redressal and timely disbursement of installments under the scheme in Andhra Pradesh; and
- (f) the details regarding awareness/outreach programmes that have been undertaken in rural and coastal districts, including Palnadu and Konaseema to ensure complete coverage of eligible farmers under the Scheme?

## **ANSWER**

THE MINISTER OF STATE FOR AGRICULTURE AND FARMERS WELFARE कृषि एवं किसान कल्याण राज्य मंत्री (SHRI RAMNATH THAKUR)

(a) to (e): The PM-KISAN scheme is a central sector scheme launched in February 2019 by the Hon'ble Prime Minister to supplement the financial needs of farmers with cultivable land-holding. Under the scheme, a financial benefit of ₹ 6,000/- per year is transferred in three equal instalments, into the Aadhaar seeded bank accounts of farmers through Direct Benefit Transfer (DBT) mode. Under the PM-KISAN Scheme, cultivable landholding is primary

eligibility criteria to receive benefit of the Scheme subject to certain exclusions relating to higher economic status.

A farmer-centric digital infrastructure has ensured that the benefits of the scheme reach all the farmers across the country without involvement of any intermediaries. While maintaining absolute transparency in registering and verifying beneficiaries, the Government of India has disbursed over ₹ 4.09 lakh Crore through 21 instalments since inception of the Scheme across the country. There is no State-wise or District-wise budget allocation under PM-KISAN, however, the District-wise and instalment-wise details of benefits released to the farmers of Andhra Pradesh including Palnadu and Konaseema Districts is attached at Annexure.

Under the PM-KISAN Scheme, States/UTs are mandated to identify and verify the eligible beneficiaries under the scheme and upload the error-free data of eligible farmers including land records, linking of Aadhaar with their bank accounts and e-KYC for successful transfer of the benefits. The registration of farmers and their verification under the Scheme is an ongoing process. Once the correct and verified data of farmers is received from the State/UTs, benefit is processed immediately by the Department and the same is released in the subsequent instalment. Further, Land seeding, Aadhaar-based payments, and e-KYC have been made mandatory under the scheme. The benefits of the farmers, who did not complete these mandatory criteria, were stopped. As and when these farmers complete their mandatory requirements, their benefits under the Scheme resume from the subsequent instalment.

To ensure the prompt resolution of issues faced by the farmers under the PM-KISAN scheme, a robust grievance redressal mechanism has been created. There is a dedicated grievance module on the PM-KISAN Portal for raising grievances by the farmers. These grievances are addressed by the State/District level officials in a time bound manner. Apart from the PM-KISAN grievance module, farmers can also register their grievances through Centralized Public Grievance Redress and Monitoring System (CPGRAMS) Portal. Further, considering the large beneficiary base of the scheme, to promptly address the general queries and grievances raised by the beneficiaries, a voice-based PM-KISAN AI Chatbot (Kisan e-Mitra) was developed. This Chatbot provides quick, accurate, and clear responses to farmers' queries round the clock in their native languages, making the system more accessible and user-friendly. It is accessible on all platforms such as web, mobile, etc. The Kisan eMitra Chatbot currently operates in 11 languages—English, Hindi, Odia, Tamil, Bengali, Malayalam, Gujarati, Punjabi, Kannada, Telugu, and Marathi.

(f): To ensure that no eligible farmers are left out from the Scheme, the Government of India often undertakes saturation drives in coordination with the State Governments including Andhra Pradesh. A major nationwide saturation drive was undertaken from 15th November 2023 under the Viksit Bharat Sankalp Yatra (VBSY), during which, more than 1.0 Cr. farmers were included under PM-KISAN. Further, under the new Government's 100 days initiative, over 25 lakh eligible farmers were added under the PM-KISAN scheme. Additionally, a special drive was conducted in September 2024 to clear the pending self-registration cases, which resulted in the addition of over 30 lakh new farmers
