TRANSACTIONS UNDER PM-KISAN SCHEME

Will the Minister of Agriculture and Farmers Welfare कृषि एवं किसान कल्याण मंत्री be pleased to state:

(a) the total number of PM-KISAN Scheme transactions that have taken place during the last five years, State-wise and district-wise details for Bihar, Madhya Pradesh and Uttar Pradesh;

(b) the total number of PM-KISAN Scheme transactions that have failed during the last five years, highlighting regions where transaction failures have been comparatively high, State and district-wise data for Bihar, Madhya Pradesh and Uttar Pradesh;

(c) whether the Government has identified the reasons behind failed transactions in Bihar, Madhya Pradesh and Uttar Pradesh such as incorrect bank account details, Aadhaar mismatches, or technical glitches;

(d) if so, the details of the reasons identified, corrective measures taken, and awareness campaigns conducted to address these issues and if not, the reasons for not having carried out such assessments; and

(e) whether the Government ensures that the failed transaction amounts are credited to the beneficiaries after rectification and if so, the details of process followed, timelines ensured and the number of beneficiaries?

ANSWER

(a) to (b): The PM-KISAN scheme is a central sector scheme launched in February 2019 by the Hon'ble Prime Minister to supplement the financial needs of farmers with cultivable land-holding. Under the scheme, a financial benefit of ₹ 6,000/- per year is transferred in three equal instalments, into the Aadhaar seeded bank accounts of farmers through Direct Benefit Transfer (DBT) mode. Under the PM-KISAN Scheme, cultivable landholding is primary eligibility criteria to receive benefit of the Scheme subject to some certain exclusions relating to higher income status.

A farmer-centric digital infrastructure has ensured the benefits of the scheme reach all the farmers across the country without involvement of any intermediaries. Maintaining absolute transparency in registering and verifying beneficiaries, the Government of India has disbursed over Rs 4.09 lakh Cr. through 21 installments since inception of the Scheme. The State-wise details of total transactions and failed transactions during the last 5 financial years is attached at Annexure-1. The district-wise details of total transactions and failed transactions during last 5 financial years in the States of Bihar, Madhya Pradesh and Uttar Pradesh are at Annexure-2, 3 and 4 respectively.

(c) to (e): During the initial phases of the PM-KISAN scheme, benefits were disbursed through the account-based mode. States/UTs were responsible for uploading beneficiaries' details on the PM-KISAN Portal, including their bank account information. This mode witnessed a high number of transaction failures due to issues such as mismatch between the beneficiary's name and the account holder name, incorrect or incomplete bank account numbers, institutional accounts, incorrect IFSC codes, multiple beneficiaries linked to the same bank account, etc.

To minimise transaction failures arising from errors in bank account details, Aadhaar Payment Bridge (APB) mode of payment was made mandatory from the 13th instalment onwards. Further, special drives, in coordination with PFMS, banks, and NPCI, were conducted to address these issues and further reduce transaction failures.

Following this shift, the transaction failures were reduced substantially. A few transaction failures that are sometimes observed relate to reasons such as Aadhaar number being de-seeded from the NPCI mapper, Aadhaar not being mapped to the bank account, closure of the bank account, etc. In all failed transaction cases, the beneficiaries are notified for rectification of the error, whereafter they are reprocessed and the benefits are transferred to the beneficiaries, immediately. As a result of various technological interventions and the efforts of the Government, the latest 21st instalment has seen a remarkable 99.86% transaction success rate as on date.
