Central Funds Released to Telangana and Tax Collection

Will the Minister of **FINANCE** be pleased to state:

- (a) the total funds released to the State Government of Telangana from the financial year 2019-20 to 2024-25, year-wise;
- (b) the specific break-down of these funds into Tax Devolution (as per the Finance Commission's recommendations), Grants-in-Aid, and the central share for Centrally Sponsored Schemes (CSS); and
- (c) the total amount (in Rs. crore) collected by the Centre Government from Telangana in the form of Direct Taxes and Goods and Services Tax (CGST + IGST) during the same period, year-wise?

(a) & (b): The Union Government provides funds to the State Governments, including the Government of Telangana under various heads suchTax Devolution from Divisible Pool of Central Taxes and Duties, Central Share for Centrally Sponsored Schemes (CSS), grants to Implementing Agencies under Central Sector Schemes, grants recommended by the Finance Commission, and other Grants/Loans /Transfers etc. Details of funds released to Telangana from the financial year 2019-20 to 2024-25, year-wise is given in the table below –
