#### **INLAND WATERWAY PROJECTS**

## MINISTER OF PORTS, SHIPPING AND WATERWAYS (SHRI SARBANANDA SONOWAL)

- (a) Inland Waterways Authority of India (IWAI), an autonomous organisation under the Ministry of Ports, Shipping & Waterways, has been conducting feasibility studies and on the basis of feasibility, 32 National Waterways (NWs) have been made operational. The details of operational NWs are given at **Annexure-1**.
- (b) The financial details of sanctioned projects for development of Inland Waterways Transport Sector are placed at **Annexure-2**.
- (c) Yes, Sir. The private sector is participating in operation and maintenance of terminals, jetties and vessels.
