STATUS OF PM-ABHIM IN UTTAR PRADESH

966. MS. IQRA CHOUDHARY:

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) the details of the projects approved, sanctioned and completed under the PM Ayushman Bharat Health Infrastructure Mission (PM-ABHIM) in the State of Uttar Pradesh, district-wise;
- (b) the amount of funds allocated, released and utilised in the said State under PM-ABHIM since its inception component-wise;
- (c) the details of the progress of Integrated Public Health Labs, Block Public Health Units, Critical Care Hospital Blocks and Urban Health & Wellness Centres being established in the State, district-wise;
- (d) the reasons for delay, if any, in project implementation along with the corrective steps taken in this regard; and
- (e) the number of posts sanctioned and currently vacant for doctors, nurses and technicians under the said mission?

(a) to (d): Under the CSS component of PM Ayushman Bharat Health Infrastructure Mission (PM-ABHIM), provisions have been made for the State of Uttar Pradesh for the construction and strengthening of 1,670 building-less Ayushman Arogya Mandir- Sub Health Centre (SHC-AAM), 674 Urban- Ayushman Arogya Mandirs (U-AAM), 515 Block Public Health Units (BPHUs), 75 Integrated Public Health Labs (IPHLs), and 74 Critical Care Blocks (CCBs) during the scheme period from FY 2021-22 to 2025-26.

The district-wise details of the projects approved, sanctioned and completed including under the PM Ayushman Bharat Health Infrastructure Mission (PM-ABHIM) in the State of Uttar Pradesh is at **Annexure**.

The details of Central Release under PM-ABHIM to the state of Uttar Pradesh since inception to FY 2024-25 is given as below:

PM-ABHIM is a capital intensive scheme and the project construction requires long gestation period. Identification of suitable land for projects requires time and MoHFW has undertaken steps like early project approvals and provided funds for establishment of Programme Management Units for technical support to the States/UTs. Technical and operational guidelines have been released and shared with States/UTs to facilitate timely completion of projects.
