COVERAGE UNDER JAL JEEVAN MISSION

*7. SHRI JANARDAN SINGH SIGRIWAL:
SHRI NABA CHARAN MAJHI:

Will the Minister of JAL SHAKTI

be pleased to state:

- (a) the present status of functional household tap water connections under the Jal Jeevan Mission (JJM) including the number and percentage of rural households covered across the country, especially in Palghar district of Maharashtra;
- (b) the States and Union Territories that have achieved hundred per cent Har Ghar Jal status and the timeline set for achieving universal coverage in the remaining States/UTs;
- (c) the coverage of tap water connections in NCT of Delhi and in schools and Anganwadi Centres across the country, State and district-wise including Cuttack along with a separate and specific status report regarding tap water connections in rural households, schools and Anganwadi Centres in Nabarangpur Lok Sabha Constituency, particularly in Nabarangpur and Malkangiri districts of Odisha;
- (d) the funds allocated, released and utilised for the implementation of JJM in Palghar district of Maharashtra during the last three years;
- (e) the progress of JJM in Rajasthan, district-wise and the names of the districts where the said work is still incomplete/in progress along with the total number of new connections sanctioned under JJM in the State, district-wise including Bhilwara Lok Sabha Constituency;
- (f) the total number of projects under JJM audited in Rajasthan so far and the total number of such cases where irregularities have been detected; and
- (g) the names of the individuals or agencies which have been found guilty in such cases and the administrative or legal action taken against them so far?

ANSWER

(a) to (g) A Statement of reply is laid on the Table of the House.

Statement referred to in the reply to parts (a) to (g) in respect of Lok Sabha Starred Question No. *7 for reply on 29.01.2026 regarding Coverage under Jal Jeevan Mission asked by Shri Janardan Singh Sigriwal and Shri Naba Charan Majhi.

(a) Significant progress has been made in the country since the launch of Jal Jeevan Mission, towards enhancing access to tap water to rural households. At the start of Jal Jeevan Mission in August 2019, only 3.23 Crore (16.72%) rural households were reported to have tap water connections. So far, as reported by State, more than 12.55 crore additional rural households have been provided with tap water connections under JJM. Thus, as on 26.01.2026, out of 19.36 Crore rural households in the country, more than 15.79 Crore (81.56%) households are reported to have tap water supply in their homes. In Palghar, as on 26.01.2026, out of 4.52 Lakh rural households, around 3.19 Lakh rural households are reported to have tap water supply in their homes.

(b) As reported by the States/UTs on JJM-IMIS, 8 states and 3 UTs (viz. Goa, Arunachal Pradesh, Haryana, Punjab, Telangana, Mizoram, Himachal Pradesh & Gujarat, A & N Islands, D&NH and D&D and Puducherry) have achieved Har Ghar Jal status. The remaining state will saturate all households as per their saturation plan.

(c) The Jal Jeevan Mission (JJM) aims to supply functional household tap connections (FHTCs) to every rural home across India. The coverage of tap connections in urban areas including NCT of Delhi is not maintained by this department. As reported by the States/UTs on JJM-IMIS, as on 26.01.2026, 89.62% schools and 85.60% anganwadi centres in the country have tap water supply connection. District-wise details of fund allocated, and utilization are not maintained at Government of India level.

(e) to (g) Since August 2019, Government of India in partnership with States is implementing Jal Jeevan Mission (JJM) – Har Ghar Jal to make provision of potable water to every rural household of the country, including those in all districts and Bhilwara Lok Sabha Constituency of Rajasthan, through functional tap water connection. As reported by the state on JJM-IMIS, at the start of Jal Jeevan Mission in August 2019, only 11.74 lakh (10.90%) rural households were reported to have tap water connections. So far, as reported by State, more than 50.86 lakh additional rural households have been provided with tap water connections under JJM. Thus, as on 26.01.2026, out of 107.73 lakh rural households in the Rajasthan, more than 62.60 lakh (58.11%) households are reported to have tap water supply in their homes. Drinking water is a State subject and the power to plan, design, approve and implement drinking water supply schemes/projects lies with State Government. Government of India supplements the efforts of the States by providing technical and financial assistance. Further, grievances/ complaints etc. are vested in respective State/ UT and are handled/ disposed at State/ UT level. Accordingly, grievances/ complaints *inter alia* including irregularities in the implementation, corruption cases and misuse of funds under this scheme, received so far in this Department have been forwarded to the respective State Government for taking necessary action. As reported by the State of Rajasthan, action has been taken in 67 cases, against 170 Departmental Officials; 53 contractors, and 2 Third Party Inspection Agencies (TPIAs).
