NEW EXPRESSWAY PROJECTS IN BIHAR

88. SHRI JANARDAN SINGH SIGRIWAL:

Will the Minister of ROAD TRANSPORT AND HIGHWAYS

- (a) whether the Government has proposed any new expressway projects in Bihar and if so, the details thereof;**
- (b) whether the Government has collaborated with the State Government of Bihar for development of expressways under the Central scheme and if so, the details thereof;**
- (c) whether any timelines have been fixed for their completion and if so, the details thereof;**
- (d) whether land acquisition for ongoing expressway projects in Bihar is progressing as per the scheduled timelines and if so, the details thereof;**
- (e) whether feasibility studies or Detailed Project Reports (DPRs) have been prepared for such expressways and if so, the details thereof; and**
- (f) whether funds have been allocated for these projects and if so, the details thereof?**

STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (f) OF LOK SABHA STARRED QUESTION NO. 88 ANSWERED ON 5TH FEBRUARY, 2026 ASKED BY SHRI JANARDAN SINGH SIGRIWAL REGARDING 'NEW EXPRESSWAY PROJECTS IN BIHAR'.

(a) Government in Ministry of Road Transport & Highways undertakes Feasibility Study/Detailed Project Report (DPR) for improvement/widening/construction of National Highways in the country including the State of Bihar. Decision for project implementation and investment is taken based on the outcome of DPR, requirement of connectivity, traffic density and synergy with PM Gati Shakti National Master Plan. As far as Bihar is concerned, following Expressway/Access Controlled Highways are under implementation/under bidding/appraisal stage:-

- a) Patna Purnea**
- b) Amas Darbhanga**
- c) Varanasi Ranchi Kolkata**
- d) Bakarpur-Bettiah**
- e) Patna Ara Sasaram**
- f) Kishanganj Bahadurganj**
- g) Gorakhpur Siliguri**
- h) Raxaul Haldia**

The brief details of the above mentioned Expressways/High Speed Corridors is annexed.

(b) Development of Expressways/Access Controlled Highways is undertaken in accordance with the provisions of the National Highways Act, 1956 under sanctioned schemes of the Central Government. No specific collaboration has been done with the State Government of Bihar for development of Expressways and Access Controlled Highways. However, the State Government is consulted during alignment finalization, land acquisition and statutory clearances for developing of these Expressways/High Speed Corridors. Further, in certain cases, the State Government has also agreed to share land acquisition cost.

(c) The proposed Expressways/Access Controlled Highways which are presently at DPR/project approval stages, the project-specific timelines shall be finalized after project approvals.

(d) Yes Sir. Land acquisition for these Expressway/ Access Controlled Highway projects has been initiated and is generally progressing as per prescribed procedures.

(e) Yes Sir. feasibility studies and/or Detailed Project Reports (DPRs) have been / are being prepared for expressway projects. The details are as mentioned in the annexure to part (a) of the Question.

(f) Allocation of funds is made only after project approval and is subject to budgetary provisions.
