- (a) the details of schemes and the funds allocated under the Ministry as per Budget Estimate for 2024–25 and 2025–26 under various schemes of the Government, scheme/year-wise;
- (b) whether the funds allocated as per Revised Estimate for 2024–25 and 2025–26 have been reduced substantially, if so, the details and the reasons therefor, scheme/year-wise;
- (c) whether the Government has not been able to spend even thirty per cent of the allocated budget for 2025–26 and is planning to reduce the allocation by sixty per cent as per 2025–26, if so, the details thereof along with the reasons therefor; and
- (d) whether the Government would rationalise the allocation as per the actual utilisation during the last two years and the current year, if so, the details thereof and if not, the reasons therefor?
