**RESIGNATION OF FEMALE EMPLOYEES WORKING IN MEDICAL
INSTITUTES**

**1220. DR. SHARMILA SARKAR:
DR. BYREDDY SHABARI:**

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) the total number of female employees who have resigned from service in central autonomous medical institutes/bodies such as various AIIMS, PGIMER, Chandigarh, JIPMER, Puducherry, NIMHANS, Bengaluru etc. during the years 2020 to 2025, institute-wise and year-wise;
- (b) the total number of No Objection Certificates (NOCs) issued to serving employees (particularly nursing and technical staff) to appear in Common Recruitment Examination (CRE) and the Nursing Officer Recruitment Common Eligibility Test (NORCET) in the said institutes/bodies during the years 2020 to 2025, institute-wise and year-wise;
- (c) whether the Government has analysed the trends regarding resignations of female employees and the issuance of NOCs for such examinations; and
- (d) if so, the details thereof along with the steps proposed to be taken by the Government to address any attrition concerns and to improve retention in this regard?

(a) to (d): The institute-wise and year-wise details of female employees resigned from service and NOCs issued to serving female employees to appear in CRE and NORCET during the years 2020 to 2025, in various All India Institute of Medical Sciences (AIIMS), Postgraduate Institute of Medical Education and Research, (PGIMER), Chandigarh, Jawaharlal Institute of Post Graduate Medical Education & Research, (JIPMER), Puducherry and National Institute of Mental Health and Neuro Sciences (NIMHANS), Bengaluru are at Annexure. Reasons for resignation of female employees and their seeking NOCs for CRE/NORCET are both personal and professional.
