HOSTELS FOR WORKING WOMEN

1332. SHRI BIPLAB KUMAR DEB:
THIRU D M KATHIR ANAND:

Will the Minister of Women and Child Development be pleased to state:

- (a) the number of hostels for working women currently existing in various States of the country;
- (b) whether the Government is planning/proposes to build more hostels in different parts of the country, if so, the details of the districts in which these hostels are proposed to be opened in different parts of the country, district-wise, including Tripura;
- (c) whether the Government has provided any funds to establish Working Women's Hostels (WWHs) in the country, if so, the details thereof, State-wise;
- (d) whether the Union Government has allocated Rs. 5000 Crore for the construction of New WWH across 28 States, if so, the details thereof, State-wise, year-wise;
- (e) whether the Union Government has conducted any study/assessment about the total requirement of number of WWHs in the country, State-wise, if so, the details thereof; and
- (f) whether the Public/Private Companies/organizations/NGOs are also approved/allowed to run the Working Women Hostels with the funding from Union Government, if so, the details thereof?

ANSWER

MINISTER OF WOMEN AND CHILD DEVELOPMENT
(SHRIMATI ANNPURNA DEVI)

(a) to (f): Sakhi Niwas Scheme [Working Women Hostel (WWH)] under the overarching Mission Shakti, is a demand driven centrally sponsored scheme where States/UTs assess their requirement as per local needs and their proposals are approved by the Programme Approval Board (PAB) after discussion with States/UTs. The Scheme aims to promote availability of safe and conveniently located accommodation for working women and for those women who are pursuing higher education and training, with Day care facility for children in urban, semi-urban and even rural areas where employment opportunity for women exists. In this scheme, fund is provided for rental accommodation. The State Governments/UT Administrations are eligible to receive financial assistance for setting up of a Sakhi Niwas.

Presently, 560 Sakhi Niwas (Working Women Hostel) are functioning across the country including Tripura. The details of the Sakhi Niwas (WWH) functioning across the country are at **Annexure-I**. The details of funds released to the States/UTs under Sakhi Niwas Scheme during 15th finance commission period is at **Annexure-II**.

Ministry of Finance (MoF), Department of Expenditure (DoE) vide O.M. No.44(1)/PF-S/2024-25 (CAPEX) dated 09.08.2024 has allocated **Rs.5,000/- crores** to **28 States** under Part (X) (Construction of Working Women Hostels) of **Special Assistance to States for Capital Investment (SASCI) Scheme** for construction of working women hostels. Under SASCI Scheme, Department of Expenditure(DoE) has approved construction of 254 working women hostels with total capacity of 52991 beds in 28 States at a total approved cost of Rs.4,826.31 crore and out of this 1st instalment of Rs.3,148.28 crore has been released to the States during 2024-25.
