IMPLEMENTATION OF PM-JANMAN

Will the Minister of TRIBAL AFFAIRS be pleased to state:

(a) the present status of pucca house construction under PM-JANMAN scheme for Particularly Vulnerable Tribal Groups (PVTGs) in the country, State-wise including Odisha, Pali Lok Sabha Constituency of Rajasthan and Palghar district in Maharashtra;

(b) the Multi-Purpose Centres sanctioned and the convergence achieved with other welfare schemes;

(c) the coverage of piped water supply, electrification and road connectivity in PVTG habitations;

(d) the monitoring mechanisms established to ensure effective implementation across the participating States; and

(e) the action taken by the Government to ensure effective last mile delivery and outreach especially for women, tribal families and economically weaker sections in Palghar district of Maharashtra and other tribal dominated districts?

(a): The status of pucca house construction under PM JANMAN for Particularly Vulnerable Tribal Groups (PVTGs) in the country, State-wise including Odisha and Palghar district in Maharashtra are given in **Annexure-I**. Based on the data captured by State Government, only Baran district in Rajasthan, which is not under Pali Lok Sabha Constituency, has PVTG population.

(b) & (c): The details of progress of multi-purpose centers along with progress of piped water supply, electrification, road connectivity and other interventions converged under PM JANMAN are given in **Annexure-II**.

(d): To ensure the effective implementation and monitoring of the PM JANMAN, Ministry has been regularly reviewing the implementation with State Governments and District administrations. Further, the State Government is also required to comply with the instructions of Department of Expenditure regarding SNA SPARSH alongwith applicable GFRs. Besides, for monitoring the progress of the works under PM JANMAN, digital dashboard on PM GatiShakti portal has been developed. A Project Monitoring Unit in the Ministry has also been established for monitoring and coordination with Ministries and States/UTs.

(e): In coordination with State Governments, Information, Education and Communication (IEC) campaigns have been organized across States including Palghar district of Maharashtra and other tribal dominated districts which are aimed at creating awareness on various welfare schemes for tribals and strengthen outreach and also facilitating in preparation of basic documents like Aadhar Card, Caste certificate, Jan Dhan bank account which are required for availing benefits under different schemes. These campaigns have primarily targeted tribal families and also covering women and economically weaker sections in the respective areas.
