Entrepreneurship and Skill Development Programme (ESDP) scheme, Prime Minister Employment Generation Programme (PMEGP), Skill Upgradation and Mahila Coir Yojana, SCST Hub, Assistance to Training Institutions (ATI) Scheme, A Scheme for promotion of Innovation, Rural Industry & Entrepreneurship (ASPIRE) and training through Technology Centres set up across the country including in Ramanathapuram, Tiruvannamalai and Kanchipuram districts.
