AGREEMENTS WITH UAE

Will the Minister of EXTERNAL AFFAIRS be pleased to state:

(a) whether India and United Arab Emirates(UAE) have recently finalised a series of agreements;

(b) if so, the key areas and focus of the said bilateral agreement indicating the major sectors on which deals were signed;

(c) whether the Government has also signed a pact for importing 0.5 million tonnes of liquified natural gas annually for 10 years starting 2028 from UAE and if so, the details thereof;

(d) the progress made under the India–UAE Comprehensive Economic Partnership Agreement (CEPA) and its impact on bilateral trade and investments so far;

(e) the steps taken/being taken to address trade imbalances, improve market access for Indian goods and services and encourage greater participation of Indian companies in the UAE market; and

(f) the future roadmap outlined by the Government to deepen the India-UAE strategic partnership in the coming years?

ANSWER

(a to b) During the visit of His Highness Sheikh Mohamed bin Zayed Al Nahyan, President of the United Arab Emirates to India, on 19 January 2026, several MoUs/ Agreements were signed and announcements made to enhance cooperation in the areas of trade and investment, energy, infrastructure, defence, technology and cultural exchanges. Details are enclosed at Annex-A and Annex-B.

(c) During the above mentioned visit, a Sales & Purchase Agreement (SPA) was signed between Hindustan Petroleum Corporation Limited (HPCL) and the Abu Dhabi National Oil Company Gas (ADNOC Gas), which provides a

long-term Agreement towards purchase of 0.5 MMPTA LNG by HPCL from ADNOC Gas over a period of 10 years starting from 2028.

(d) The India-UAE Comprehensive Economic Partnership Agreement (CEPA) was signed on 18 February 2022 and came into force from 1 May 2022. India-UAE bilateral trade has increased from USD 72.87 billion in FY 2021-22 to USD 100.06 billion in FY 2024-25. India's merchandise exports to the UAE have grown steadily, supported by preferential market access on over 97% of tariff lines covering 99% of Indian exports in value terms.

(e) The Government is engaging closely with the UAE through the CEPA institutional mechanisms to address trade imbalances, improve market access and promote participation of Indian companies in the UAE market. Both sides have agreed to work towards expanding non-oil, non-precious metal trade and diversifying the trade basket. Sector-specific issues relating to agriculture, pharmaceuticals, standards, customs procedures, certification, and gems & jewellery are being discussed regularly under the Joint Committee framework of the India UAE CEPA.

(f) The India-UAE Comprehensive Strategic Partnership relationship is driven by sustained engagement at the highest levels of leadership.

Government of India is committed to deepen its multifaceted cooperation with UAE in the traditional sectors of cooperation, while expanding collaboration into new and strategic areas.
