- (a): The PM Internship scheme is being implemented as a national level scheme in which internship opportunities were posted across districts/cities in all States/UTs. However, the internship opportunities posted by the companies in Beed and Parbhani districts of Maharashtra in Round I are 23 and 10 respectively and in Round II are 44 and 21 respectively.**
- (b): The sector-wise details of companies offering internship opportunities in both the rounds of PMIS Pilot Project in Maharashtra is placed at Annexure I.**
- (c): The district-wise number of internship offers made under the scheme in Maharashtra is attached at Annexure II.**

(d): The number of interns belonging to OBC, SC and ST categories who joined under both the Rounds of the Pilot Project are as follows:-
