IMPLEMENTATION OF KSVY IN ASSAM

4838. Shri Gaurav Gagoi :

Will the **MINISTER OF CULTURE** be pleased to state:

- (a) the details of the total number of beneficiaries covered under the Kala Sanskriti Vikas Yojana (KSVY) during the last five years, State/UT and year-wise, particularly in Assam,
- (b) whether the Government maintains data on Non-Governmental Organisations (NGOs), cultural organisations and individual artists assisted under the scheme;
- (c) if so, the number of Assam-based NGOs, cultural organisations and individual artists received support under KSVY during the said period;
- (d) the details of total funds allocated and disbursed under KSVY during the last five years, along with the share released to Assam and other North-Eastern States; and
- (e) the details of the steps taken by the Government to ensure transparency, timely release of funds and improved outreach of the scheme, particularly among rural and grassroots cultural practitioners in Assam?

(a) Ministry of Culture implements Kala Sanskriti Vikas Yojana (KSVY), under which financial assistance is provided to eligible cultural organizations and individual artists engaged in performing arts across the country, including the State of Assam. The State/UT-wise details of number of beneficiaries (NGOs, cultural organisations and individual artists), along with the amount disbursed/authorized under various components / sub-components of KSVY during the last five years are given at **Annexure-I**.

(b) & (c) Yes, Sir. The data on Non-Governmental Organisations (NGOs)/ cultural organizations and individual artists assisted under the scheme are maintained in the Ministry. The details of number of Assam based NGOs, Cultural Organizations and individual artists received support under KSVY during the last five years are given at **Annexure-II**.

(d) Kala Sanskriti Vikas Yojana (KSVY) is a Central Sector Scheme and there is no provision for State-wise allocation of funds. However, the details of the total funds allocated and disbursed under KSVY during the last five financial years are as under:
