576. SHRI MALVINDER SINGH KANG:

Will the Minister of FISHERIES, ANIMAL HUSBANDRY AND DAIRYING

be pleased to state:

- (a) the details of funds allocated and infrastructure created by the Government under National Livestock Mission for Punjab specifically Anandpur Sahib Lok Sabha Constituency;
- (b) the details/list of cattle rearing units including goat/sheep rearing units in rural areas like Garshankar in Hoshiarpur district, Balachaur in Nawanshahr district and milk processing plants supported in Chamkaur Sahib in Ropar district;
- (c) the number of women self-help group trained and provided breed improvement subsidies under the Mission in villages of Hoshiarpur's Garhshankar, Ropar's Chamkaur Sahib; and
- (d) the steps taken/being taken by the Government to integrate livestock insurance with Pradhan Mantri Fasal Bima Yojana (PMFBY) for small ruminant farmers in such districts?

ANSWER

- (a) Under National Livestock Mission (NLM) Rs. 369.66 Lakh is allocated to Punjab State during last five year in various components of the scheme.
- (b) No cattle rearing units including goat/sheep rearing units in rural areas like Garhshankar in Hoshiarpur district, Balachaur in Nawanshahr district has been established. The number of goat and sheep unit supported under Entrepreneurship Development Programme of National Livestock Mission in Punjab is given as under:

Department of Animal Husbandry & Dairying (DAHD), Government of India is implementing “National Programme for Dairy Development (NPDD)” scheme.
