(a) whether it is a fact that Corporate Social Responsibility (CSR) Funds are being misused by a number of companies resulting in the CSR amount not being utilised for the intended social works, if so, the details thereof;

(b) whether cases of misuse of CSR funds by companies have come to the notice of the Government during the last five years, if so, the year-wise details thereof; and

(c) the names of companies against which action has been taken by the Government for violation of CSR rules and misusing the funds during the last five years?
