**MICRO FOOD PROCESSING UNITS SUPPORTED UNDER PMFME SCHEME**

Will the Minister of **FOOD PROCESSING INDUSTRIES** be pleased to state:

- (a) the total number of Micro Food Processing units supported through credit-linked subsidy under the Pradhan Mantri Formalisation of Micro Food Processing Enterprises (PMFME) Scheme up to December, 2025 in the country including Pali Constituency of Rajasthan and Nabrangpur district of Odisha;
- (b) the details of seed capital released to Self-Help Group (SHG) members and the number of beneficiaries trained under the scheme especially in Rajasthan including in the said district; and
- (c) the measures being taken to strengthen market linkages for One District One Product (ODOP) clusters and micro enterprises, particularly in Nabrangpur district/Nabrangpur Lok Sabha Constituency in Odisha?

**(a) & (b):** Under the Pradhan Mantri Formalisation of Micro food processing Enterprises (PMFME) Scheme, as on 31<sup>st</sup> December 2025, loans have been sanctioned for 1,72,707 micro food processing enterprises across the country under Credit-Linked subsidy component.

The progress under Credit-Linked Subsidy, Seed Capital and Capacity Building for Pali Constituency of Rajasthan & Nabrangpur district of Odisha as on 31<sup>st</sup> December, 2025, is mentioned below:

**(c):** Under the PMFME Scheme, Branding and Marketing support is provided to the groups of Farmers Producer Organisations (FPOs)/ Self Help Groups (SHGs)/ Cooperatives or Special Purpose Vehicle (SPV) of micro food processing enterprises with a grant of upto 50% of the eligible project cost. The component follows the cluster approach for developing a common brand with provision for quality control, standardisation, packaging and adhering to food safety parameters for consumer retail sale. Till 31<sup>st</sup> December 2025, 27 proposals have been approved and 35 One District One Product (ODOP) brands have been supported across the country. However, no proposal for Branding & Marketing has been received from Nabrangpur constituency of Odisha.
