**ULTRA MEGA SOLAR PROJECTS**

Will the Minister of NEW AND RENEWABLE ENERGY be pleased to state:

- (a) the total number of Solar Parks and Ultra-Mega Solar Power Projects sanctioned under the Solar Park Scheme since inception along with the total sanctioned capacity (in MW) during the last five years, year-wise;
- (b) the solar capacity (in MW) commissioned under the Scheme during the last five years along with the capacity currently under construction and capacity pending or yet to be awarded, year-wise;
- (c) the total Central Financial Assistance (CFA) sanctioned and released under the Scheme during the last five years, State and year-wise; and
- (d) the details of pending proposals particularly from Andhra Pradesh including project location, land availability status, statutory and environmental clearances, transmission evacuation arrangements, CFA requested and released along with the reasons for delay in approval or implementation?

**ANSWER**

- (a) A total of 55 Solar Parks of cumulative capacity of 39,973 MW have been sanctioned under the scheme or “Development of Solar Parks and Ultra Mega Solar Power Projects”. The year-wise details of solar parks sanctioned during last 5 year are placed at **Annexure I**.
- (b) Out of the total sanctioned capacity of 39,973 MW, a capacity of 16,121 MW has been commissioned in the Solar Parks, out of which 8176 MW has been commissioned in the last five years. The details of solar capacity commissioned during last 5 years is placed at **Annexure II**.
- (c) The total Central Financial Assistance (CFA) released under the Scheme during the last five years, State and year-wise is placed at **Annexure III**
- (d) Currently no proposals from Andhra Pradesh are pending at MNRE under the scheme. The CFA released to Andhra Pradesh is placed at **Annexure III**. In all, 4200 MW has been sanctioned to Andhra Pradesh.
