(a) &(b): Yes, Madam. Fourteen Member Advisory Council has been constituted under the Chairmanship of Shri Som Mittal, former President NASSCOM (National Association of Software and Services Companies) and Member, Expert Committee on HR (Human Resource) policy for e-governance set up by National e-Governance Division (NeGD) to assist in the drafting of the IT (Information Technology) Vision for the Indian Railways. The other Members of the Advisory Council are:

The terms of reference of the Council are as under:

- i) To assist in developing a comprehensive ICT (Information & Communication Technology) vision for Indian Railway which is in line with the overall vision and objectives outlined for Railways;**
- ii) The ICT Vision to cover Information Technology, Communication and Telecom as well as Geospatial. The current ICT implementation to be reviewed & integrated into the new vision;**
- iii)To specifically integrate and cover passenger service, freight services, asset management and train operations, safety and security as well as operations/enterprise management of Railway;**
- iv)To recommend an implementation strategy and structure to ensure timely complete execution of the vision.**
- v) To recommend plan for effective capacity building, change management and IT governance; and**
- vi)To suggest the road map to set up a technology portal which would invite innovative technological solutions for Rail Specific issues.**

(c): So far, five meetings of the Council has been held on 07.05.2015, 13.05.2015, 29.05.2015, 11.06.2015 & 02.07.2015.

(d): The Council is likely to submit its draft report by the end of August 2015.
