RENEWABLE ENERGY PROJECTS FOR RURAL AREAS

*343. SHRI SHIVKUMAR UDASI: SHRI ALOK SANJAR:

Will the Minister of NEW AND RENEWABLE ENERGY be pleased to state:

- (a) whether the bio-gas and other renewable energy projects for cooking, heating and power needs particularly in remote/rural areas of the country are under implementation and if so, the details thereof;
- (b) the number of villages where bio-gas plants and other renewable energy units have been set up during each of the last three years and the current year, State/UT-wise;
- (c) the funds provided to various States for the purpose during the said period, State/UT-wise; and
- (d) the steps taken by the Government to promote bio-gas cooking stove and other renewable projects especially for rural areas of the country?

ANSWER

THE MINISTER OF STATE FOR POWER, COAL & NEW AND RENEWABLE ENERGY (INDEPENDENT CHARGE) (SHRI PIYUSH GOYAL)

(a), (b), (c)&(d): A statement is laid on the Table of the House.

Statement referred to in reply to parts (a),(b),(c)& (d) of the Lok Sabha Starred Question No. 343 for 13.08.2015 regarding Renewable Energy Projects for Rural Areas by Shri Shivkumar Udasi and Shri Alok Sanjar

- (a): Yes, Madam. The Ministry of New and Renewable Energy is implementing important programmes such as the National Biogas and Manure Management Programme (NBMMP), Unnat Chulha Programme (UCP), Biogas Power (Off-grid) Generation Programme (BPGP), Biomass Gasifiers Programme, Remote Village Electrification Programme, and dissemination of Solar Lighting and Solar Cookers for meeting cooking, heating and power needs in the remote / rural areas of the country.
- **(b):** The State/ UT-wise number of villages where family type biogas plants and biogas based power plants (Off-grid) have been set up during each of the last three years and the current year 2015-16 upto 30.06.2015 are given at **Annexure I**. The State-wise nos. of villages where Solar Lighting Systems, Mini grid (Community Power Plants) and villages electrified under the Remote Village Electrification (RVE) Programme are given at **Annexure** –**II**.
- (c): The details of State—wise and year-wise funds released during each of the last three years and current year 2015-16 under the National Biogas and Manure Management Programme (NBMMP), Biogas Power (Off-grid) Generation Programme (BPGP), Unnat Chulha Programme (UCP) and Gasifier are given at **Annexure-III**.
- (d): Installation of family type biogas plants under the National Biogas and Manure Management Programme (NBMMP) are provided with capital subsidy, turn-key job fee for supervision of installation and free maintenance warranty for five years for trouble free functioning of biogas plants, support for organization of training courses, workshop & seminars and information & publicity through print and electronic media. The State Nodal Agencies/ Departments and Khadi and Village Industries Commission (KVIC) and Biogas Development Training Centres are provided Administrative Charges for implementation according to the annual targets and achievements there on. Under the newly launched Unnat Chulha Programme (UCP), the Ministry is providing Central Financial Assistance towards cost of improved cook stoves, training, user's orientation, publicity and awareness generation and monitoring and evaluation. Central financial assistance for power generation and for thermal applications are available under the schemes.
