- (a) whether the Government has received proposals for irrigation projects from various States including Maharashtra for approval;
- (b) if so, the details thereof;
- (c) the details of projects sanctioned so far along with the details of the pending projects, State-wise; and
- (d) the steps proposed to be taken for early clearance of the pending projects?

- (a) to (c) The Government have received proposals for environmental clearance for irrigation projects from various states including Maharashtra. During the last 3 years and including current year, twelve (12) irrigation projects have been accorded environment clearance (EC). A list of these 12 projects is annexed. No irrigation project is pending for approval for environment clearance.
- (d) Steps and procedures as stipulated in Environment Impact Assessment Notification 2006 are followed by the Government while considering the proposals for environment clearance.
