#### **ALLEGED IRREGULARITIES IN IAY**

#### 1782. SHRI KIRTI AZAD: SHRI BAHADUR SINGH KOLI:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) Whether the Government has received any complaints of alleged irregularities in implementing the Indira Awas Yojana (IAY) from various States during the last three years and the current year;
- (b) if so, the details thereof and the action taken by the Government in this regard, State/UT-wise; and
- (c) the remedial measures taken by the Government to check such irregularities?

# ANSWER MINISTER OF RURAL DEVELOPMENT (SHRI BIRENDER SINGH)

- (a) and (b): A statement indicating the State-wise complaints received under IAY during the last three years is given in the Annexure.
- (c): The Government of India has issued an advisory to deal with the cases of corruption and irregularities under IAY. The same has been circulated to State Governments/UT Administration for taking appropriate action. In addition to that the Ministry deputes National Level Monitors for conducting specific inquiry regarding irregularities committed under IAY.
